

# CALL FOR APPLICATIONS FOR THE FREE LOAN FOR USE TO STUDENTS OF THE UNIVERSITY OF 600 ALMABIKES – A.Y. 2020/2021

(Issued with P.D. File no. . 5944/2020 dated 05/10/2020)

### DEADLINE FOR APPLICATIONS: 12/11/2020 – time: 3 p.m.

As part of the actions taken to promote sustainable mobility in urban areas, and in order to incentivise the use of bicycles to travel short and medium distances, the University is making available **600** bicycles produced as part of the Almabike Project for use by its students.

The bicycles will be loaned free of charge to students whose applications are successful. The loan period is for one year and a deposit of €99.00 is required.

## Art. 1 - General requirements for admission to the competitive selection procedure

In order to apply, students must be properly enrolled for the 2020/2021 academic year in a first- or second-cycle degree programme or a single-cycle degree programme at the Alma Mater Studiorum - University of Bologna on the application deadline date.

#### Art. 2 - Deadlines and procedures for submitting applications

The deadline for the submission of applications is 12/11/2020 at 3 p.m.

Applications to participate in the call must be submitted by the closing date exclusively via the "Studenti Online" application.

To use the application:

- 1. access studenti.unibo.it using your University username and password;
- 2. click on the "calls for applications" button;
- 3. select the "Call for applications for the free loan for use to students of the university of 600 Almabikes A.Y. 2020/2021"

#### **NOTES:**

- a. The application will be deemed valid only if the student completes the above procedure correctly;
- b. It is important to check all the contact details indicated
- c. It is not possible to submit the application in paper format or by email.



## Art. 3 – Procedure for accessing the benefit

Each candidate will be notified of the outcome of the application process by email sent to the university email address (<a href="mailto:nome.cognome@studio.unibo.it">nome.cognome@studio.unibo.it</a>).

The successful applicants will receive detailed information on how the Almabike will be delivered and on payment of the €99.00 deposit.

If, following the application deadline, the number of suitable applicants exceeds 600, the Almabikes will be allocated to the first 600 suitable candidates in line with the chronological order in which applications were received.

### Art. 5 - Loan for use fees and deposit

Students borrowing the Almabikes will be expected to pay for bike maintenance with the exception of any structural repairs required related to factory defects.

With regard to the aforementioned maintenance, students must follow the instructions in the communication that will be issued in relation to this competition.

At the end of the loan period, students must return the bikes following the procedures that will be communicated to them. Once the state of repair of the Almabike has been checked, the deposit of €99.00 paid at the start of the loan period will be returned to the student, with the cost of any repairs that may be necessary deducted.

In the event that the bicycle is stolen, the entire deposit will be retained.

#### Art. 6 - Preference

In future competitions, preference will be given to students that travel the most number of kilometres using the bicycle loaned for use following this competition.
