**CALL FOR APPLICATIONS
FOR THE ALLOCATION OF 11,666 DATA SIM CARDS WITH 100 GIGABYTES OF DATA PER
MONTH, VALID FOR ONE SEMESTER, TO STUDENTS OF THE UNIVERSITY OF BOLOGNA
WITH A VIEW TO REINFORCING THE DIGITALISATION OF TEACHING AND STUDENT
SERVICES IN THE 2020/2021 ACADEMIC YEAR**

DEADLINE FOR APPLICATIONS: 16/10/2020 – time: 3 p.m.

As part of the actions taken to reinforce the digitalisation of teaching and student services, the Alma Mater Studiorum - University of Bologna is offering DATA SIM cards with 100 gigabytes/month of data, valid for one semester, to students enrolled in the 2020/2021 academic year.

Art. 1. Number of cards available

10,659 DATA SIM cards, valid for one semester, with 100 gigabytes/month of data will be available to students whose application is successful.

PLEASE NOTE: Due to UE Regulation n. 531/2012 the SIM Card can be used only in the following countries: Austria, Belgium, Bulgaria, Cyprus, Croatia, Denmark, Estonia, Finland (including Aland Islands), France (including overseas territories: Martinique, Réunion, Guadelupe, French Guiana), Germany, United Kingdom (including Gibraltar, Guernsey, Jersey, Isle of Man), Greece, Ireland, Italy, Island, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Norway, the Netherlands, Poland, Monaco, Portugal (including Azores and Madeira), Czech Republic, Slovakia, Romania, Slovenia, Spain (including the Canary Islands), Sweden, Switzerland, Hungary, Republic of San Marino and the Vatican City.

Art. 2 General requirements for admission to the competitive selection procedure

In order to apply, candidates must meet the following requirements by the deadline for applications:

- 1) they must be enrolled for the 2020/2021 academic year on a first or second-cycle degree programme or a single-cycle degree programme of the Alma Mater Studiorum - University of Bologna lasting a number of years equal to the standard duration of the degree programme increased by 1;
- 2) they must have an ISEE 2020 calculation for benefits in relation to the right to Higher Education not exceeding €35,000 (see instructions in art. 4 regarding how to submit the ISEE).

Art. 3 - Deadlines and procedures for submitting applications

The deadline for the submission of applications is **16/10/2020 at 3 p.m.**

Applications to participate in the call must be **presented by the closing date exclusively via the “Studenti Online” application.**

To use the application:

1. access studenti.unibo.it using your University username and password;
2. click on the “calls for applications” button;
3. select the “Call for applications for the allocation of 10,659 data SIM cards with 100 gigabytes/month of data, valid for one semester, to students enrolled in the 2020/2021 academic year.

PLEASE NOTE:

- a. The application will be deemed valid only if the student completes the above procedure correctly;
- b. It is important to check all the contact details indicated in the relative section on Studenti Online - particularly the residential address
- c. It is not possible to submit the application in paper format or by email.

Art. 4 – Procedure for accessing the benefit

Each candidate will be notified of the outcome of the application process by email sent to the university email address (nome.cognome@studio.unibo.it).

Successful candidates will receive the SIM card sent directly by Telecom Italia Mobile to the residential address indicated by the student in the personal details section on Studenti Online in Italy or in Republic of San Marino or in the Vatican City

Successful candidates whose residential address is in a different country will be requested to indicate an address in Italy to send the SIM card.

In the event there are fewer than 10,659 successful candidates, the unallocated cards will be made available to other students through specific competitive selection procedures that will be announced following expiry of this call for applications.

Art. 5 Formulation of the ranking list

If, following expiry of this call for applications, the number of successful candidates exceeds 10,659, the University will rank the candidates in ascending order in respect of the ISEE 2020 value calculated for benefit purposes in relation to the right to Higher Education.

PLEASE NOTE: In order to submit the ISEE, log on using your University username and password to the "[Online Services](#)" section of the ER.GO website and fill in the "Dati personali" (Personal details) and "Dati economici" (Economic data) sections **before the competition deadline**. The "Economic Data" section requires the Self Certification (DSU) registration number obtained from INPS, which is needed to obtain the ISEE.

International students who cannot request the ISEE can find detailed information about how to submit the documentation for the calculation of their economic status on the University website at the following link www.unibo.it/documentitasse.

NOTE: Submission of the ISEE and/or documentation needed to check economic status for the purposes of this call is also valid for the calculation of the tuition fee payable on enrolment for the 2020/2021 academic year.

Art. 6 – Incompatibility

The allocation of the SIM card referred to in this call for applications is incompatible with that provided for by the Regional Authority for the Right to Higher Education (ER.GO) resulting from the relative Notices issued in the first half of 2020.

Art. 7 – Checks and penalties

The ISEE certificates will be subject to the checks envisaged by the applicable regulations and carried out by ER.GO on behalf of the University of Bologna.

In the event of a negative outcome of the aforementioned checks, the person to whom the SIM has been allocated will be required to return it to the University following the procedures that will be indicated in an email sent to the university email address nome.cognome@studio.unibo.it.

Art. 8 – Communications

All University communications to students applying for the benefit will be deemed validly sent if sent to their institutional e-mail addresses (name.surname@studio.unibo.it).
