ART.1 – The Alma Mater Studiorum University of Bologna and the Fondazione Sfameni, pursuant to article 5 of the Articles of Association of the Foundation adopted by notarial decree, Ref. no. 3670 File 2144 of 24.11.2010 and Prefectural Decree of 04.02.2011, have issued a Competition/Call for Applications for the award of a two-year International Prize, in the name of Prof. Pasquale Sfameni, to a researcher who has made important contributions to research in physiology, physiopathology and genetics of pregnancy and the development and evolution of the placenta, also investigated with modern approaches of genetics and molecular medicine and which offer significant advances on the theories originally developed by Prof. Sfameni.
This Prize refers to the two-year period 2017-2018.

ART.2 The following works will be considered:

- original articles published in the international press in the ten year period prior to the deadline of the call for applications;
- essays or chapters of books published in the same period.

ART.3 – The Prize, worth a total of 27,000 € will be paid in two instalments: the first instalment of 13,500€, together with the commemorative plaque, will be awarded at a public ceremony, during which the winner will give a lecture to illustrate the main results of his/her research, and to which the representative of the Sfameni family will be invited to participate; the second instalment of 13,500€ will be paid no later than 30.09.2019.

ART.4 – The competition is open to researchers of any nationality; their contribution to the applicable fields of research must be evident from both their curriculum vitae and the impact and international renown of the presented publications.

ART.5 – The Jury will comprise 3 professors, one appointed by the School of Medicine, one by the School of Agriculture and Veterinary Medicine and one by the School of Science.
A representative of the family may also participate in the works of the Jury.

ART.6 – Methods of award

The Prize will be awarded by the Jury according to the following criteria:

- Assessment of the candidates' curriculum vitae;
- Assessment of the international importance of the presented publications;
- Assessment of the importance of the results achieved in the advancement of knowledge and treatment in the applicable fields of interest.

ART.7 – Applications must be presented on unstamped paper addressed to the Rector (Magnifico Rettore dell'Università di Bologna, Ufficio Premi e Borse di Studio - Via delle Belle Arti, 42, 40126 Bologna), delivered by hand or by courier/postal service by the deadline during public opening

hours (Monday, Wednesday, Friday 9.00/11.15 a.m. – Tuesday 9.00/11.15 a.m. and 2.30/3.30 p.m. – Thursday 2.30/3.30 p.m.).

If sent by post, the receiving stamp of the Grants and Scholarships office or Protocol office will act as proof of receipt. Applications received after such date will not be considered.

In their applications candidates must indicate:

- surname and name, date and place of birth, place of residence, telephone number and e-mail address;
- nationality;
- their highest academic qualification, with indications of date and place of award;
- address for all communications concerning the competition.

Applications must be accompanied by the following documents:

- a) Curriculum vitae List of publications presented for evaluation in the competition and printed copies of any, in particular of essays and chapters of books that are not available from on-line databases. The documentation enclosed with the application will not be returned.

ART.8 – The Jury will appoint the winner in a motivated report, and reserves the right to not award the Prize if it does not consider any of the candidates to be worthy.

ART.9 – The Prize will be awarded by Management Decree and delivered by the University Administration.

ART.10 – Within 60 days from the date of award of the Prize, the winner shall agree on a date for the award ceremony with the administration, providing the title of the lecture he/she will give during the ceremony.

ART.11 – If no applications are received or if in any case the Prize is not awarded or not implemented for any reason whatsoever, the relative amount will be used for other activities provided for in the Articles of Association of the Foundation.

ART.12 - The personal data provided shall be processed in compliance with the principles and provisions of Italian Legislative Decree no. 196/2003 (Data Protection Act) and GDPR UE n.2016/679, in any case exclusively for the purposes of this call for applications.

The data will be processed using electronic and manual (paper) methods. The provision of the requested data is compulsory for the purposes of processing your application.
