# Call for applications for the award of an International Prize in the name of "Prof. Pasquale Sfameni" for the 2019/2020 period $V^{\text{Th}}$ edition

## CLOSING DATE FOR APPLICATIONS: 29 MAY 2021 ORE 12:00

**ART.1** - The Alma Mater and the Sfameni Foundation, pursuant to art. 5 of the Articles of Association of the Foundation adopted by notarial deed, Ref. no. 3670 File 2144 of 24.11.2010 and the Order of the Prefect dated 04.02.2011, have issued a Call for Applications for the award of a biennial International Prize, in the name of Prof. Pasquale Sfameni, to a researcher who has made important contributions to research in the fields of physiology, pathophysiology, pregnancy genetics and placental development, investigated also using modern approaches to genetics and molecular medicine, that offer significant advances on the theories originally developed by Prof. Sfameni. This Call for Applications applies to the two-year 2019/2020 period.

**ART.2** - Consideration will be given to:

- original articles published in the international press in the ten-year period prior to the application deadline;

- essays or book chapters published in the same period.

**ART.3** - The Prize, worth a total of €22,000, will be paid in two instalments:

- the first instalment of €11,000.00, will be paid upon the Prize being awarded;

- the second instalment of  $\notin 11,000.00$ , together with a commemorative plaque, will be awarded at a public ceremony, during which the winner will give a talk to illustrate the main results of his/her research, and in which a representative of the Sfameni family will be invited to participate;

The time, place and procedures of the official award ceremony will be determined at a later date depending on the status of the current health emergency.

**ART.4** - The competition is open to researchers of any nationality. Their contribution to the applicable fields of research must be evident from both their curriculum vitae and from the impact and international renown of the publications submitted.

**ART.5** - The Award Committee will comprise 3 Teachers of the University of Bologna, one appointed by the School of Medicine, one by the School of Science and one by the Department of Veterinary Medicine.

A representative of the family may also participate in the work of the Committee.

#### ART.6 - Award methods

The Prize will be awarded by the Award Committee, based on the following criteria:

- assessment of the candidate's curriculum vitae;
- assessment of the international importance of the publications submitted;
- assessment of the importance of the results achieved in the advancement of knowledge and treatments in the applicable fields of interest.

**ART.7** - Applications must be submitted ONLY by email, together with the required attachments, sent to:

Applications must be sent no later than 29 May 2021 ore 12:00.

Applications sent after the deadline or via other means will not be considered.

The candidate's application must include:

#### The candidate's application must include:

- 1) their surname and name, date and place of birth, residence, telephone number and email address;
- 2) their highest qualification, with the date and place it was awarded;
- 3) the address to which all communications concerning the competition are to be sent.

#### The application to participate must be accompanied by the following documents:

- a) curriculum vitae,
- b) list of publications submitted for assessment in the competition and printed copies thereof, in particular of essays and book chapters not available in online databases.
- c) photocopy of a valid ID document.

**ART.8** - The Committee will announce the winner in a report containing the grounds for their decision, reserving the right not to award the prize if no suitable candidates are identified.

**ART.9** - The prize will be awarded by a Decree issued by senior management and disbursed by the University administration.

**ART.10** - Within 60 days of receiving formal notification of the award, the winner must agree with the administration on a date for the award ceremony and provide the title of the lecture he/she will give during the ceremony.

**ART.11** - If no applications are received or if the prize is not awarded or the award not implemented for any reason, the relative amount will be used for other activities provided for in the Foundation's Articles of Association.
