***ABSTRACT***

English abstract of the Call for Scholarships “**A.A.2023-2024 - BANDO PER L’ATTRIBUZIONE DI N. 2 (DUE) BORSE DI STUDIO DESTINATE A STUDENTI INTERNAZIONALI CHE SI ISCRIVONO AL 2 ANNO DEL CURRICULUM ADVANCED MATHEMATICS FOR APPLICATIONS - CORSO DI LAUREA MAGISTRALE IN MATEMATICA (codice 5827)**”

**Art. 1 – Subject and amount**

The Department of Mathematics has announced a call for n. 2 scholarships of the amount of € 5.000 each (gross of all charges), reserved for deserving international students enrolling for the academic year. 2023-24 in the second year of the Master's Degree Course in Mathematics, Curriculum Advanced Mathematics for Applications.

**Art. 2 – Incompatibility**

The scholarship is incompatible with other scholarships/prizes for the same purpose assigned by the University of Bologna, by ER.GO, by MAECI, by the Collegio Superiore di Bologna, by CRUI for students under international protection (quota referred to meals).

**Art. 3 – Eligible Candidates**

Admission to selection procedure is valid only for who

- have enrolled to the second year of the international curriculum Advanced mathematics for applications, second cycle degree Mathematics – Department of Mathematics, University of Bologna;
- have obtained at least 30 credits relating to courses included in the Master's Degree Course in Mathematics, Curriculum Advanced Mathematics for Applications by 30 September 2023;
- has not reached the age of 30 on 30 September 2023.

**Art. 4 – Assignment**

The scholarships will be assigned by grading max 30 point as follows:

- Credits (ECTS/CFU): max 25 points
- Curriculum vitae: max 5 points

In the event of parity between several candidates the scholarship will be assigned to the youngest.

### **Art. 5 – Application procedure and deadline**

**To take part in this call, apply by November 23, 2023, within 6 PM (CET)**

### **Art. 6 - Acceptance**

Within the peremptory terms of **ten days** starting from the formal communication date of the assignee, fellows must send full acceptance and fiscal details to the following email address: [mat.didattica@unibo.it](mailto:mat.didattica@unibo.it)

Under the responsibility of the assignee, the acceptance form is valid to declare there are no incompatibility as in art. 2. Any changes shall be promptly declared.

### **Art. 7 – Payment**

The provision of the scholarship is subject to possession of the participation requirements described in article 3 of this call.

In order to receive the scholarship, the winners must give written confirmation via e-mail to [mat.didattica@unibo.it](mailto:mat.didattica@unibo.it) that all registration procedures have been completed (including the online payment receipt for the first instalment).

After the offices have verified registration, the scholarship will be disbursed in a single instalment.

The University of Bologna reserves the right to carry out checks on the veracity of what is declared. Without prejudice to the sanctions provided for by art. 76 of Presidential Decree 445/2000, if the check reveals the untruthfulness of the content of the declarations provided, the declarant will lose the scholarship even after the assignment of the contributions.

### **Art. 8 - Withdrawal**

**Withdrawal must be promptly notified via e-mail to [mat.didattica@unibo.it](mailto:mat.didattica@unibo.it)**

In case of withdrawal or incomplete documents, the scholarship will be assigned to the next in the ranking list. The same will occur in case of transfer to a different degree programme in the academic year 2023/2024, and the scholarship need to be reimbursed.
