**CALL FOR N. 4 STUDENTSHIPS RESERVED TO APPLICANTS TO ERASMUS MUNDUS MASTER'S DEGREE IN CHEMICAL INNOVATION AND REGULATION FOR THE ACADEMIC YEAR 2021/22**

**Deadline: July 15<sup>th</sup> 2021**

**ART. 1 - DEFINITION**

A call for applications is open for the attribution of n. 4 studentships worth € 5,000 each (gross of charges by the institution and the contributor) reserved to students enrolled to the Erasmus Mundus "Chemical Innovation and Regulation" (CHIR) Master's Degree Course for the academic year 2021/22. This activity is carried out and financed by the initiative "Miur Departments of Excellence", pursuant to Italian Law no. 232/2016.

**ART. 2 – REQUIREMENTS**

Participation to the call is open to all candidates who have applied for admission to the Erasmus Mundus CHIR Master's Degree Course and in possession of the following requirement:

1. not being awarded with an Erasmus Mundus scholarship.

**ART. 3 – APPLICATION FORM AND DEADLINE**

Applications according to the model set out in Annex 1 must be received without any delay before:

**12.00 (C.E.T.) of 15/07/2021**

by e-mail to: [science.international@unibo.it](mailto:science.international@unibo.it) indicating in the subject: "Call for CHIR studentships" (request for reading notification is strongly recommended).

The candidate is responsible to verify the correct receipt of the application. The Office does not assume any responsibility arising from reception problems.

**Applications received after the aforementioned deadline will not be taken into consideration.**

A photocopy of a valid identity document or passport must be attached to the application form.

The administrative offices reserve the right to carry out checks on the authenticity of the statements.

Beside the penalties provided for by art. 76 of Italian Presidential Decree 445/2000, if the check should reveal the untruthfulness of the content of the declaration, the declarant immediately loses the right to receive the award.

**ART. 4 – EVALUATION BOARD AND SELECTION CRITERIA**

The Evaluation Panel is composed as follows: Prof. Emilio Tagliavini (President), by Prof. Marco Lombardo (member) and by Prof. Alessandra Tolomelli (secretary member).

The requirement reported in art. 1 will be verified by the Evaluation Panel. In order to be assessed, applicants must have reported an admission score to the aforementioned Course equal to or higher than 20 out of 25.

If the number of participants possessing the aforementioned requirements is higher than the number of grants available in this call, the Evaluation Panel will rank the candidates on the basis of the score awarded for admission to the Course.

Applicants must certify whether they are holders of another contribution for merit in the same academic year 2021/22 either a scholarship or other financial support from the University of Bologna or other institutions. In case, they must declare the total amount of the existing contribution. In such case, the amount of the studentship will be reduced by an amount equivalent to the contribution already received. On the basis of the ranking formulated by the Evaluation Panel, the studentships will be awarded upon completion of enrollment in the Degree Program as specified in art 7 of this announcement.

**ART. 5 - INCOMPATIBILITY**

The studentship is not cumulable with the Erasmus Mundus scholarship, nor with financial contributions of any kind from the University of Bologna referring to the same academic year and aimed at rewarding merit. Non-accumulation means that the award will be reduced by an amount equivalent to the contribution received.

### **Art. 6 – NOTICE OF STUDENTSHIP AWARD AND ACCEPTANCE**

Awarded candidates will receive communication via e-mail.

The names of the winners will be published on the portal of the University of Bologna and on the Degree Course website.

Within the deadline of ten days from the date of the formal communication of the studentship award, the beneficiary must send to the address [science.international@unibo.it](mailto:science.international@unibo.it) under penalty of exclusion, a declaration of acceptance without reservation and further documents relating to tax and personal data that will be sent later.

With this declaration, the recipient of the studentship must also explicitly confirm, under his own responsibility, not to have the incompatibilities reported in art. 5 of this announcement and ensure to communicate any changes that may occur during the year with respect to what has been declared.

### **Art. 7 - METHOD OF STUDENTSHIP PAYMENT**

Payment of the studentship will take place in a single instalment and will be subject to the actual admission and enrollment of the student to the aforementioned degree program, which will be verified by this Office.

With regard to international students, for the purposes of admission and enrollment, all the mandatory provisions and deadlines must be accomplished, including what requested by the Circulars of the Ministry of University and Research, regarding the access of foreign students to master degree courses.

The scholarship will be paid by bank transfer to a bank account or a prepaid card with Italian IBANs registered with the name (or joint name) of the beneficiary student. Payment can also be made to bank accounts with non-Italian IBANs, but in this case the related bank charges will be deducted from the amount.

### **Art. 8 – STUDENTSHIP WAIVER OR FORFEITURE**

In case the beneficiary renounces the studentship, communication must be promptly sent via e-mail to the aforementioned address.

The beneficiaries that will not be regularly enrolled to the Master within the deadlines specified in Art. 7 will be considered decayed and must return the undue studentship, if already paid.

In case of renunciation or decadence, the studentship will be assigned to the next suitable candidate in the ranking list. In case of transfer to another degree course during the academic year 2021/2022, the winner will be considered renouncing and must therefore return the full amount of the award.

### **ART. 9 - PERSONAL DATA PROCESSING**

Personal data will be collected by the University, through applications to this competition.

The data collected will be processed in compliance with the principles and provisions on personal data protection and confidentiality protection established by Legislative Decree 30.06.2003 n. 196 and by the GDPR UE n. 2016/679, and will be used in any case exclusively for the purposes indicated in this Notice and for the time strictly necessary. The same processing will be applied both to data received by e-mail or by paper mail.

Availability of the requested data is mandatory for admission to the application: failure to communicate them may result in the student being excluded from the selection.

In relation to the data processing, the applicant is guaranteed the rights reported into the current legislation on the protection of personal rights.

The Data Controller is identified in the Alma Mater Studiorum - University of Bologna, based in Bologna, Via Zamboni n. 33, 40126 Bologna.

The Responsible for data processing for the aforementioned rights guarantee is the Department Director, Prof. Marco Lucarini. Pursuant to Law 241/90, the person in charge of the procedure relating to the granting of the benefit, which is in the responsibility of the University, is identified in the figure of the Administrative and Management Manager of the Department, Pier Paolo Palmieri.
