

**A.Y. 2023/2024
CALL FOR FINANCIAL SUPPORT
TO PARTICIPATE IN INTERNATIONAL SPRING OR SUMMER SCHOOLS 2024**

IMPORTANT NOTICE

This abstract has been translated into English just for publicity purposes. For any application and/or dispute resolution and/or for any legal purpose only the Italian version must be taken into consideration.

With reference to the A.Y. 2023/2024, it is announced a call for the assignment of **n. 25 financial incentives** to participate in **international Spring or Summer schools/workshops** which will take place in the **period 1st May – 30th September 2024**, in Italy or abroad, **organized by higher education institutions or research centers other than the University of Bologna.**

ADMISSION REQUIREMENTS

To participate in the call, **applicants must be regularly enrolled for the A.Y. 2023/24 to one of the following master's degrees: Physics (code 9245); Astrophysics and Cosmology (code 5828); Science of Climate (code 5895); Fisica del Sistema Terra (code 8626).**

EVALUATION CRITERIA

The selection will be carried out by an examining commission which will proceed according to the following criteria:

- mark obtained in the three-year degree: max 20 points;
- average weighted on the credits of the master's degree course exam results: max 40 points;
- curriculum vitae: max 40 points.

The maximum score attributable to each candidate is set at 100 points; eligibility is achieved with a minimum score of 60.

FINANCIAL INCENTIVES

The **n. 25 financial incentive** will be distributed as follows among the students enrolled in the considered master's degrees:

The incentives will be provided as a flat-rate economic incentive and partial of the expenses incurred by the winners, within the limit of € 400 (gross amount) for each beneficiary.

The disbursement of the incentive will take place after sending the confirmation of registration and participation in the Spring/Summer school attended. **Only certificates that bear the words "Spring/Summer School/Workshop" are eligible.**

The documentation for receiving the incentive must be presented no later than 18 October 2024, according to the procedures that will be communicated by e-mail to the winning students.

APPLICATION AND DEADLINE

The application to participate in the competition must be submitted exclusively through the "Studenti Online" application **no later than 3rd July 2024 by 6 p.m.**

How to apply:

1. Log in to "Studenti Online" using your credentials.
2. Click on the "Bandi" button.
3. Select the call titled " BANDO PER L'EROGAZIONE DI INCENTIVI ECONOMICI PER PARTECIPARE A SPRING O SUMMER SCHOOL INTERNAZIONALI 2024".

The following documents in "pdf" format must be uploaded on Studenti Online, under penalty of exclusion from the competition:

- 1) Curriculum vitae updated, dated, and signed.
- 2) Brief description of the chosen Spring/Summer school: place and period of development, title and program of the school, link to the school's web page, relevance to the current university career.

PUBLICATION OF NOTICES AND FINAL RANKINGS AND COMMUNICATION OF RESULTS

The notice will be published on the website *Bandi, gare e concorsi — Università di Bologna* to the section <https://bandi.unibo.it/agevolazioni/borse>

Candidates will be able to check the results of the assessment within the "Studenti online" (SOL) platform.

The first candidates usefully positioned in the final merit ranking, explicitly indicated as winners, will be winners of the scholarship.

The winners will be notified of the award by email.

WINNERS: HOW TO ACCEPT

Documentation required for the acceptance of the incentive must be sent to the DIFA (clarissa.consaga@unibo.it) **no later than n. 10 days from the date of communication of the grant assignment.**

The required documents must be completed in full in all parts, signed in original. Failure to accept within the indicated deadline will implicitly represent the waiver of the incentive by the successful candidate.

INSURANCE

The formal approval of the final merit ranking will constitute the formal authorization to guarantee insurance coverage for winners and suitable candidates during the trip and for the period of the school/workshop, in Italy or abroad.

WAIVER AND CONDITIONS SUSPENSIVE

In the event of withdrawal following acceptance of the incentive, the student must promptly notify the DIFA (clarissa.consaga@unibo.it). The withdrawing student will be required to return any sums already received.
