# CALL FOR N. 2 SCHOLARSHIPS RESERVED TO APPLICANTS AND SECOND-YEAR STUDENTS OF ERASMUS MUNDUS MASTER IN CHEMICAL INNOVATION AND REGULATION FOR THE ACADEMIC YEAR 2022/23

Deadline: July 15th 2022

#### **ART. 1 - DEFINITION**

A call for application is open for the attribution of n. 2 fellowships worth € 5,000 each (gross of charges by the institution and the contributor) reserved to students enrolled or applying to the Erasmus Mundus "Chemical Innovation and Regulation" (CHIR) Master's Degree Course for the academic year 2022/23.

## **ART. 2 – REQUIREMENTS**

Participation to the call is open to all candidates who:

- a) have submitted an application for admission to the Erasmus Mundus CHIR Master's Degree Course in possession of the following requirements: not being awarded with Erasmus Mundus grant;
- b) are enrolled as second-year self-paying students of the Erasmus Mundus CHIR Master's Degree Course for the a.y. 2022/23.

#### **ART. 3 – APPLICATION FORM AND DEADLINE**

Applications, on plain paper, according to the model set out in Annex 1 must be received without any delay before:

#### 12.00 (C.E.T.) of 15/07/2022

by e-mail to: <a href="mailto:science.international@unibo.it">science.international@unibo.it</a> indicating in the subject: "Call for CHIR scholarships" (request for reading notification is strongly recommended).

The candidate is responsible to verify the correct receipt of the application. The Office does not assume any responsibility arising from reception problems.

### Applications received after the aforementioned deadline will not be taken into consideration.

A photocopy of a valid identity document or passport must be attached to the application form.

The administrative offices reserve the right to carry out checks on the authenticity of the statements.

Beside the penalties provided for by art. 76 of Italian Presidential Decree 445/2000, if the check should reveal the untruthfulness of the content of the declaration, the declarant immediately loses the right to receive the award.

## ART. 4 – EVALUATION BOARD AND SELECTION CRITERIA

The evaluation of the applications will be carried out by a special Evaluation Board composed as follows: Prof. Emilio Tagliavini (President), by Prof. Marco Lombardo (member) and by Prof. Alessandra Tolomelli (secretary member). The requirements reported in art. 1 will be verified by the Evaluation Board.

If the number of participants in possession of the aforementioned requirements will exceed the number of grants available in this call, the Evaluation Board will draw up a merit ranking based on the following priority criteria:

- score awarded for admission to the Course (for applicants to the Erasmus Mundus CHIR Master's Degree Course); students with an admission score lower than 20/25 will be excluded from ranking.
- grade average (for second-year students).

Applicants must certify whether they are holders of another contribution for the same academic year 2022/23 - in the form of a scholarship or other financial support - aimed at rewarding merit from the University of Bologna or other entities. Otherwise, they shall declare the total amount of the existing contribution.

If the commission select applicants who already enjoy other contributions, to ensure equal treatment for all students, the amount of the scholarship will be reduced by an amount equivalent to the contribution already received. Based on the ranking formulated by the Evaluation Board, the scholarships will be awarded upon completion of enrollment in the Degree Program as specified in art 7 of this announcement.

#### **ART. 5 - INCOMPATIBILITY**

The scholarship is not cumulable with the Erasmus Mundus scholarship, nor with financial contributions of any kind from the University of Bologna referring to the same academic year and aimed at rewarding merit. Non-accumulation means that the award will be reduced by an amount equivalent to the contribution received.

#### Art. 6 - NOTICE OF SCHOLARSHIP AWARD AND ACCEPTANCE

The fellowships will be awarded based on the evaluation carried out by the Evaluation Board.

Successful candidates will receive communication via e-mail.

The names of the winners will be published on the University portal and on the Degree Course website.

Within the mandatory deadline of ten days from the date of the formal communication of the scholarship award, the winner must send to the address <a href="mailto:science.international@unibo.it">science.international@unibo.it</a> under penalty of exclusion, a declaration of acceptance without reservation and further documents relating to tax and personal data that will be sent later.

With this declaration, the recipient of the scholarship must also explicitly confirm, under his own responsibility, not to have the incompatibilities reported in art. 5 of this announcement and ensure to communicate any changes that may occur during the year with respect to what has been declared.

## **Art. 7 - METHOD OF SCHOLARSHIP PAYMENT**

Payment of the scholarship will take place in a single instalment and will be subject to the actual admission and enrollment of the student to the aforementioned degree program, which will be verified by this Office.

The scholarship will be paid by bank transfer to a bank account or a prepaid card with European IBANs registered with the name (or joint name) of the beneficiary student. Payment can also be made to bank accounts with non-Italian IBANs, but in this case the related bank charges will be deducted from the amount.

#### Art. 8 - SCHOLARSHIP WAIVER

In case the winner renounces the scholarship, communication must be promptly sent via e-mail to the aforementioned address.

In case of renunciation, the scholarship will be assigned to the next suitable candidate in the ranking list. In case of transfer to another degree course during the academic year 2022/2023, the winner will be considered renouncing and must therefore return the full amount of the award.

#### **ART. 9 - PERSONAL DATA PROCESSING**

Personal data will be collected by the University, through applications to this competition.

The data collected will be processed in compliance with the principles and provisions on personal data protection and confidentiality protection established by Legislative Decree 30.06.2003 n. 196 and by the GDPR UE n. 2016/679, and will be used in any case exclusively for the purposes indicated in this Notice and for the time strictly necessary. The same processing will be applied both to data received by e-mail or by paper mail.

Availability of the requested data is mandatory for admission to the application: failure to communicate them may result in the student being excluded from the selection.

In relation to the data processing, the applicant is guaranteed the rights reported into the current legislation on the protection of personal rights.

The Data Controller is identified in the Alma Mater Studiorum - University of Bologna, based in Bologna, Via Zamboni n. 33. 40126 Bologna.

The Responsible for data processing for the aforementioned rights guarantee is the Department Director, Marco Lucarini. Pursuant to Law 241/90, the person in charge of the procedure relating to the granting of the benefit, which is in the responsibility of the University, is identified in the figure of the Administrative and Management Manager of the Department, Pier Paolo Palmieri.
