Call for applications for 3 study prizes for students enrolled in the EIT-Labelled Master's Degree Programme - Raw Materials Exploration and Sustainability

Academic year 2020/2021.

(Decision of the Council 15/07/2021)

## ART. 1 - Object and addressees

The Department of Biological, Geological and Environmental Sciences of the Alma Mater Studiorum - University of Bologna, sets up 3 study awards to deserving students of the University of Bologna enrolled in the EIT-Labelled, Master's Degree Programme named - Raw Materials Exploration and Sustainability. Academic Years 2019/2020 and 2020/2021

## ART. 2 - Amount

The three prizes will have different amounts, namely € 2,000 for the first winner, € 1,700 for the second winner and € 1,300 for the third winner. The prizes will be awarded in one installment. The prize will be paid by the Norwegian University of Science and Technology, Trondheim - Department of Geoscience and Petroleum in one installment.

## ART. 3 – Assignment and evaluation of titles.

The Prize will be awarded through an open competition for qualifications only by the Selection Committee, which will assess the merits based on two evaluation criteria. The first evaluation criterion will be the grades achieved at the time of application, weighted by the number of credits acquired. The second criterion will be the degree of achievement of the EIT OLOs as inferred from exercises, laboratory work, or any other documented Master's activity that is part of the RaMES programme and that will be presented in the application.



Credits belonging to a component of an integrated/modular examination will be considered in the assessment criteria, even if the entire integrated/modular examination has not yet been registered. In this case, a signed declaration by the teacher responsible must be attached to the application. Candidates scoring at least 30 points but not more than 50 points will be deemed to have passed the assessment.

The Selection Committee shall be made of the following members:

## ART. 5 - Submission of applications.

The application to take part in the competition must be submitted by the deadline exclusively by accessing the "online students" application.

- 3. Select the call for applications "Study prizes for best student EIT-Labelled Raw Materials Exploration and Sustainability a.y. 2020-2021" c/o the Department of Biological, Geological and Environmental Sciences of the University of Bologna.
  - Only candidates who meet the requirements set out in art. 3 of the call will be able to continue with the online application,

- a) The application is valid only if the student completes the above procedure;
- b) It is not possible to send the application in paper format or by e-mail to the offices.



# The following documents in "pdf" format must be attached to the application form, under penalty of exclusion from the competition:

- a) certificate attesting the grades obtained;
- b) Any additional document demonstrating the candidate's profile approach to the teaching programme, and in particular to the achievement of the EIT OLOs (<a href="https://eit.europa.eu/our-activities/education/eit-learning-outcomes">https://eit.europa.eu/our-activities/education/eit-learning-outcomes</a>)
- c) declaration of instructor in case of integrated/modular examination not yet registered. The Administration reserves the right to carry out checks on the truthfulness of the declarations. Without prejudice to the criminal sanctions provided for by art. 76 of DPR 445/2000, if the check reveals that the content of the declaration is not true, the declarant shall forfeit the study award.

## ART. 6 - Prize Awarding

The prize will be awarded by decree of the Head of the Department according to the evaluation of the Selection Committee, which will be published at https://bandi.unibo.it by 15 November and presented at the 2021 End of Course Meeting.

### ART. 7 - Acceptance.

The assignee must notify the Administration the acceptance of the award within a fixed term of 7 days, under the penalty of exclusion from the award. The acceptance must be notified without reservations, and must be sent to the official email address of the University of Bologna. Only notifications via email will be accepted.

### ART. 8 - Waiving.

In the event of the winner withdraw, at the unquestionable discretion of the Selection Committee, the prize will be made available to eligible competitors in the order of their ranking.

### ART. 9 – Responsible for the procedure

## ART. 10 – Legal and economic status

The use of study awards does not create an employment relationship.
