**CALL FOR APPLICATIONS FOR GRANTS TO SUPPORT STUDENT'S MANDATORY MOBILITY RESERVED  
FOR REGISTERED STUDENTS AT EMJMD ERASMUS MUNDUS WOP-P - ACADEMIC YEAR 2023/2024**

**EXPIRY DATE: MAY 6<sup>th</sup> 2024**

**ART. 1. TYPES OF GRANTS, SCOPE AND REQUIREMENTS**

The Course EMJMD ERASMUS MUNDUS WOP-P of Alma Mater Studiorum - Università di Bologna" calls for applications for grants to support student's mandatory mobility.

The grants are reserved for registered students at EMJMD Erasmus Mundus WOP-P in Academic Year 2023/24 on the following scheme:

- n. 4 scholarships for students enrolled in the academic year 2023/24 **in the first year** of the WOP-P International LM Course;
- n. 6 scholarships for students enrolled in the academic year 2023/24 **in the second year** of the WOP-P International LM Course.

Students accomplishing the following requirements can apply:

1. to be enrolled in the 1<sup>st</sup> or 2<sup>nd</sup> year of the WOP-P International Master's Degree Course for the academic year 2023/24;
2. not holding an Erasmus Mundus grant;
3. not having other forms of economic support aimed at international mobility from the University of Bologna or other entities for the academic year 2023/24 for amounts exceeding a total of € 2,800.00, for students enrolled in the first year; for amounts exceeding a total of € 2,000.00, for students enrolled in the second year.

To be eligible for the grant, all three conditions must be met at the same time.

**ART. 2. DOCUMENTATION**

To participate in the competition, candidates must submit the following documentation:

**a) application form filling in the specific form, fully signed;**

**b) Copy of a valid identity document.**

The above declarations are made pursuant to art. 19, 46, 47 Presidential Decree 445/2000.

In case of incomplete documentation, the application will not be taken into consideration.

**ART. 3. APPLICATION PROCEDURE**

Applications for the competition, filling in the attached form, must be submitted to the Admin Department of Psychology, Agriculture and Veterinary Medicine, Piazza Aldo Moro n. 90, Cesena **not later than 12.00 on May 6<sup>th</sup> 2024**.

Applications must be sent **exclusively** via the institutional mailbox (name.surname@studio.unibo.it) with the subject "Call for Mobility LM WOP-P 2024" to the address [campuscesena.didattica.psi@unibo.it](mailto:campuscesena.didattica.psi@unibo.it). Applications by e-mail must be sent in a single pdf format and with a single submission (partial submissions will not be accepted).

The offices are not responsible for any delays, dispersions, inconveniences due to unforeseeable circumstances, technical or other.

**Applications received after the deadline will not be considered.**

N.B. it's mandatory to attach a copy of a valid identity document.

**ART. 4. AMOUNTS**

The amount of the scholarships will be € 2.800,00 each (gross), for students enrolled in the first year and € 2,000.00 each (gross), for those enrolled in the II year.

The amount of the grant may be increased up to € 3.500,00 (gross recipient), in the case of students enrolled in the first or in the second year who have paid the entire enrollment amount as Partner Country student (€ 9.000,00).

The scholarships will be awarded to students enrolled in the WOP-P International Master's Degree Course for the academic year 2023/24.

**ART. 5. EVALUATION COMMITTEE AND CRITERIA**

The evaluation of applications will be carried out by a Commission, appointed for this purpose, composed as follows: Prof. Rita Chiesa (President), Dott. Marco De Angelis (member) and Dr. Sergio Sangiorgi (secretary).

The requirements referred to in art. 1 will be verified directly by the Commission.

Further criteria may be established by the Evaluation Commission if necessary, or if the number of participants in possession of the mandatory requirements is greater than the number of grants made available in the call.

Applicants must certify in the application whether they are holders for the same academic year 2023/24 of another contribution - in the form of a scholarship or other financial support - to international mobility from the University of

Bologna or other entities and, if so, for what total amounts. In case of winners who benefit of these contributions, to ensure equal treatment for all WOP-P students, the amount of the scholarship will be reduced by an amount equivalent to the contribution received. Any sums made available in this way will be divided equally among all winners (including the recipients of additional contributions). On the basis of the ranking formulated by the commission, the scholarships will be awarded.

#### **ART. 6. INCOMPATIBILITY**

In accordance with the resolution of the Academic Senate of 26.07.2016, about incompatibility in the context of international mobility:

- 1) it is not possible to benefit, in the same academic year, from two or more mobilities with the same purpose, therefore it is not compatible with the Erasmus Mundus scholarship;
- 2) it is possible to benefit from other forms of economic support aimed at international mobility from the University of Bologna or other entities for the academic year 2023/24 for overall amounts lower than € 2,800.00 (gross recipient) for students enrolled in the first year, or € 2,000.00 (gross recipient) for those enrolled in the second year, for forms of economic support aimed at international mobility by the University of Bologna or other bodies for the academic year. 2023/24; In this case, the scholarship will be reduced by an amount equal to any contribution received by the candidate.

#### **ART. 7. NOMINATION OF THE WINNERS - RENOUNCES**

Based on the evaluation carried out by the Commission, the scholarships will be awarded. Successful candidates will receive written communication by e-mail. The names of the winners will be made public on the University portal and on the Degree Course website. The contribution will be paid in a single solution. In case of renouncement, the amounts will be allocated to a similar contribution, to be assigned in subsequent calls, always reserved for students enrolled in the International Degree Course WOP-P.

#### **ART. 8. FURTHER OBLIGATIONS FOLLOWING THE ASSIGNMENT OF THE GRANTS**

The winners must return the forms relating to the registry, the methods of payment and deductions and the one relating to the declaration of acceptance of the scholarship, duly completed and signed.

#### **ART. 9. TREATMENT OF PERSONAL DATA**

Personal data will be collected by the University through applications to participate in this competition. The data collected will be processed in compliance with the principles and provisions on the protection of personal data and the protection of confidentiality established by Legislative Decree 30.06.2003 n. 196 and by the GDPR UE n. 2016/679, and in any case exclusively for the purposes indicated in this Notice and for the time strictly necessary for this. The treatment of data may be carried out both by computer systems and in manual form with paper means. The return of the requested data is mandatory for admission to the procedure referred to in this announcement: failure to communicate them may result in the student being excluded from the benefit. In relation to the processing of the data in question, the data subject is guaranteed the rights referred to in the current legislation on the protection of personal rights. The Data Controller is identified in Alma Mater Studiorum - University of Bologna, based in Bologna, Via Zamboni n. 33, 40126 Bologna. The Data Processor for the exercise of the aforementioned rights is the Manager of the Cesena Campus Area.
