By the final deadline of **July 5<sup>th</sup> 2024**, admitted candidates must send to <u>didatticaforli.em.info@unibo.it</u> the following documents, which they will receive via e-mail, otherwise they will lose their position:

- The acceptance form;
- The fiscal and personal information forms that will be sent them via e-mail;
- A receipt proving their registration to the Summer School (by July 1<sup>st</sup> 2024)

The payment receipt must be sent as soon as possible and, in any case, after receiving the notification of acceptance by the foreign partner Institution.

Please note that admitted candidates must enrol in the Summer School independently by **July 1st 2024** via the following link: <a href="https://utrechtsummerschool.nl/courses/business-economics/sustainable-investing">https://utrechtsummerschool.nl/courses/business-economics/sustainable-investing</a>, paying the enrolment fee (after being accepted by the partner University). You will find the instructions to enrol in the Summer School below.

- Go to the web page of the course Sustainable Investing on the USS site;
- Click on the orange 'Apply for course' button on the right side of the page;
- Add housing and continue (this is what we normally advise), unless the student wishes to find accommodation for the duration of the course him/herself;
- Click on 'register as new student' (at the right) make sure your profile is complete before continuing;
- Your cart will show: the course, housing (if chosen), and the sleeping bag/pillow
  - You can remove the sleeping back, however in that case you should bring your own sleeping bag/duvet and pillow!
  - o In all cases please bring your own towels
- Click continue;
- Include your Short Motivation, and the programme level you are in;
- Neglect the box 'partnercode'
- Click 'continue to review your application', check all information;
- Click the box to agree to 'Terms and Conditions and the cancellation policy';
- Click 'Apply for course';
