# CALL FOR ASSIGNMENT OF THE "MIREES MOBILITY SCHEME" PLACES FOR STUDY AND RESEARCH ABROAD AT SAINT PETERSBURG STATE UNIVERSITY, A.Y. 2021/22

#### Content and objective:

On the basis of the Inter-University Cooperation Agreement for the Joint Organization and release of a Second Cycle Degree, Master of Arts in Interdisciplinary Research and Studies on Eastern Europe (Mirees), foreseeing that students attend the third semester at one of the Mirees partner universities (other than the University of Bologna) or at an associated university, the Forlì Campus has opened the assignment procedure for the assignment of study grants in order to carry out a mobility period at Saint Petersburg State University in the Fall semester 2021/22.

The mobility is an integral part of the student teaching programme and is aimed at carrying out educational activities in order to fulfil the required number of University credits, as well as the research activities related to the master's thesis.

### Available places:

The number of places offered by Saint-Petersburg State University for the Fall semester 2021/22 is 10 (ten).

## Requirements:

The call is open to first-year students enrolled in the master's degree in Interdisciplinary Research and Studies on Eastern Europe (Mirees) in the academic year 2020/21.

## Application procedure:

Applications must be submitted by 11 February 2021 h 13:00 (CET) through the online service Studenti Online, by following the instructions reported below:

- 1. connect to www.studenti.unibo.it with the personal user ID and password;
- 2. click on "Bandi"/"Calls";
- 3. select the call "Mirees Mobility Scheme\_Saint Petersburg State University";
- 4. Upload the following documents:
- **Self-certification of the applicant's degree certificate** with a list of exams, **ONLY** if the first-cycle degree was not obtained from the University of Bologna;
- A personal study and research project for the mobility period and a motivation letter;
- **Any other attachments** deemed useful for assessment purposes;
- Copy of the student identity card or passport.

The application is valid only if the student completes the procedure described above and submits all the required documents. It is not possible to submit the application in paper format or by email to our office.

**Deadline:** 11 February 2021 h 13:00 (CET)

### Evaluation criteria and examining commission:

The applications will be evaluated according to the following criteria:

## Ranking:

After the assessment of applications taking into account the above-mentioned criteria, the commission will draw up a final ranking. In case of equal score, the priority will be given to the youngest candidate.

The ranking will be published on Studenti Online. Successful candidates will be informed by e-mail.

# Obligations following the assignment:

Successful candidates are requested to communicate to <u>didatticaforli.sps-sde@unibo.it</u> their acceptance of the exchange within 7 days from the notice of assignment, ensuring that they will respect the conditions set by the call and that they engage to avoid any incompatibility.

Failure to send the acceptance within the given term will be equivalent to renunciation.

Selected candidates will receive the forms of personal data and fiscal data by e-mail and are requested to deliver the forms duly completed and signed to <u>didatticaforli.sps-sde@unibo.it</u> 30 days before departure.

In case of renunciation, selected students will have to send a written communication to <u>didatticaforli.sps-sde@unibo.it</u> and the exchange place and corresponding grant will be assigned to the next eligible candidate in the ranking list.

#### **Grant:**

The grant allocated to selected students does not take the form of scholarships intended to cover all expenses, but rather represents a grant towards the additional expenses associated with living abroad.

Selected students will receive a gross grant amount of up to € 1.700,00 (+ IRAP) on the basis of the number of days actually spent abroad.

The Mirees Mobility grant will be paid in two instalments (the first instalment within December 2021 and the second instalment within July 2022) and is conditional on the payment of tuition fees for the academic years 2020/2021 and 2021/2022 and on the presentation of the documents and forms requested for processing the payment.

In compliance with the decision of the Academic Senate of 26/07/2016 on incompatibilities in the framework of international mobility 1) it is not possible to receive more grants for the same mobility period, regardless of the purpose; 2) it is possible to carry out more mobility periods provided that they do not overlap.

In compliance with the Academic Regulation of the Degree Programme, the mandatory mobility shall be of at <u>least 5 months</u>. <u>Any length reduction or extension must be previously authorized by the Coordinator of the Degree Programme</u>. In case students awarded the Mirees Mobility Scheme carry out a mobility period shorter than 5 months, the grant will be subject to a reduction. In case the student is allowed to extend his/her mobility period, the programme will not assign an additional grant to cover the extended period.

In the case that the student does not carry out the mobility scheme in the established period nor does s/he acquire any of the credits foreseen during the mobility, the amount paid must be returned.
