**ABSTRACT OF THE CALL FOR APPLICATION FOR 8 STUDY GRANTS ADDRESSED TO STUDENTS
ENROLLED IN: *ECONOMICS OF TOURISM; ECONOMICS OF TOURISM CURRICULUM IN
INTERNATIONAL TOURISM AND LEISURE INDUSTRIES;
TOURISM ECONOMICS AND MANAGEMENT***

Art. 1 Subject

The head of the Rimini and Ravenna Campus of the Alma Mater Studiorum – University of Bologna issues the call for applications for the selection of offers **8 students**, who will be attending the Acept Project week about “*Cultural heritage and tourism off the beaten track*” taking place in Rimini from 20 to 26 November 2022 <https://accept.jimdofree.com/accept-2022-italy/>

No CFU will be assigned.

Selected students will cover registration fees **inclusive of**: local transport during the excursions; all the meals – but 1; use of material to prepare the assignments in the host country; attending the programme, for a max of € 400,00. Selected students will not receive the amount of money.

Art. 2 Eligibility

Applicants shall meet the following requirements:

- 1) Be enrolled for the academic year 2021/2022 to the first cycle degree programme in Economics of Tourism or Curriculum in International Tourism and Leisure Industries or the second cycle degree programme in Tourism Economics and Management,
- 2) Finalize enrollment to the academic year 2022/2023 within due date: should selected students graduate before the taking place of the Project Week, he/she will be replaced with students in ranking list.
- 3) To have 45 CFU (for second year students) or 90 CFU (for third year students) by the deadline of this call for applications,
- 4) not having participated in the previous ACEPT Project Weeks.

Art. 3 Application procedure

Deadline for application: 15th September 2022 (12:00pm) exclusively via StudentiOnline:

1. login www.studenti.unibo.it
2. select “Call for applications” button (*Bandi*)
3. Select the title of the call for applications.

Art. 4 Selection procedure

Based on merit (academic results and cv) and interview.

Evaluation criteria:

- Merit and CV: max 40 points
- Interview: max 60 points

Applicants shall reach min. 60/100 points to be accepted.

The **Interview** will take place **22 September 2022 starting at 3:00pm** in Meeting Room, via Angherà, 22 – second floor. In case of urgent and unexpected event, the candidate will be able to require a **virtual call, upon written request 5 days prior the interview.**

The interview will take place in English language to test language skills and to prove the motivation of each candidate. Absent candidates will be excluded from the selection.

This call for applications is valid as convocation.

Art. 5 Results

The scholarships will be assigned as follows:

- 4 for the second cycle degree TEAM
- 2 for the first cycle degree CLET, international curriculum ITALI
- 2 for the first cycle degree CLET.

In case of less candidates for each degree course, the place will be assigned to the other degree courses according to the rankings.

Art. 6 Acceptance

Selected candidates need to confirm acceptance of the grant within 10 days from official notification.

Art. 7 Withdrawal

Those successful candidates who renounce for any reason will have to provide written and timely information in order to allow replacement with a reserve candidate.

Art. 8 Information notice concerning data processing
