Art. 1 – Subject and amount

The Head of the Campus of Ravenna and Rimini of the Mater Studiorum – Università di Bologna, offers 2 scholarships – one for EU and one for NON-EU students – of the amount of € 1.000,00 each (before taxes), to students enrolled for the academic year 2020/2021 in the above-mentioned degree programme.

Art. 2 – Admission requirements to the assignment of the grant.

The eligible candidate must possess the following requirements:

- Be regularly enrolled in third year for the a.y. 2020/2021 (cohort 2018/2019) in the First Cycle Degree Programme Economics of Tourism – Curriculum in International Tourism and Leisure Industries
- Have completed all exams by the deadline of this call with GPA higher than 28/30

Art. 3 – Selection procedures

Selection procedure will be merit base: sum of grades in each exam, weighted with credits. Score = lump sum (exam grade x CFU number).

30L will count 31 points.

In case of equal score, the youngest will prevail.

Art. 4 - Application procedure: terms and conditions

The application form (Attachment 1) shall delivered within:

12.00PM ON 28 JUNE 2021

via e-mail at: campusrimini.didatticaseas@unibo.it, stating in the object: “Application call for outstanding academic achievement scholarship – ITALI” (select read receipt before sending).

The candidate is responsible for the delivery of the message, the office is not taking any responsibility in case of misplaced messages. No applications will be considered after due date.

The following documents shall be attached to the application form:

- transcript of records (with GPA);
- copy of a valid ID.

The administrative offices will be checking the authenticity of the declaration.

In case of false declaration, and according to art. 76 del DPR 445/2000, the candidate will be dismissed from any right to receive the scholarship.
