**N. 2 scholarships for students enrolling in first year of the Second Cycle Degree Programme in Tourism Economics and Management – University of Bologna, Campus of Rimini**

#### **Art. 1 – Subject and amount**

Following the notice of call for applications for the admission to the Second Cycle Degree Programme in Tourism Economics and Management located in Rimini - Alma Mater Studiorum – Università di Bologna - Rep. n. 76/2022 prot. n. 30701 date 8/2/2022, the Head of the Campus of Ravenna and Rimini of the Alma Mater Studiorum – Università di Bologna, announces the selection for 2 scholarships for the amount of € 5.000 each (before tax), addressed to students that will first enroll in the academic year 2022/2023 to the above mentioned Second Cycle Degree programme, as follows:

- 1 scholarship for EU or NON-EU candidates, accepted from intake A,
- 1 scholarship for EU or NON-EU candidates, accepted from intake B.

**In case the scholarship in intake A will not be assigned, the scholarship will be available for intake B candidates.**

**Enrollment** means in first year. Any enrolment in following years, transfer or changes will not be considered (art. 3, 13, 14 del Regolamento Studenti, D.R. 464/2013).

#### **Art. 2 - Eligible Candidates**

Admission to selection procedure is valid only for who already applied in admission procedure for the Second Cycle Degree Programme **in Tourism Economics and Management**, under condition:

- To have graduated in a foreign University,
- To be ranked in admission ranking list with a score equal or higher than 75 points.

#### **Art. 3 – Application procedure and timeline**

Candidates shall provide the attached **application form** within:

- **20 April, 2022 at 12.00PM in case of application in intake A,**
- **04 July, 2022 at 12.00PM in case of application in intake B,**

via e-mail at: [campusrimini.didatticaseas@unibo.it](mailto:campusrimini.didatticaseas@unibo.it), obj.: **“Call for applications Intake A - TEAM” or “Call for applications Intake B - TEAM”** (it is recommended to select *read receipt*).

**It is responsibility of the candidate to check delivery of the application. The office is not responsible for delivery.**

**No application will be accepted after the deadline.**

A valid ID must be attached together with application form.

The office will verify the validity of any declaration. In case of false declaration, the scholarship will be cancelled (art. 76 of the DPR 445/2000).

#### **Art. 4 – Assignment**

The scholarship will be assigned by the same evaluation Committee as for the admission to the Degree Programme in Tourism Economics and Management, based on the same ranking list that will be available within 3/5/2022 (intake A) and within 14/7/2022 (Intake B), and will be paid upon final enrolment as stated according to art. 7 of this call for applications, which has to be finalized by no later that **31/10/2022**.

#### **Art. 5 – Incompatibility**

The scholarship is incompatible with other scholarship/ prizes for the same purpose, assigned by the University of Bologna (included Unibo action 2 and Unibo for Refugees), by ER.GO, by MAECI, by the Collegio Superiore di Bologna, by CRUI for students under international protection (quota referred to meals). The scholarship is compatible with other fundings assigned by ER.GO (for example fee waiver, accommodation, food tickets, etc.)

#### **Art. 6 - Acceptance**

Within the peremptory terms of ten days starting from the formal communication date of the attribution to the day of the official notification of the assignment, the assignee must send full acceptance and fiscal details to the following email address: [campusrimini.didatticaseas@unibo.it](mailto:campusrimini.didatticaseas@unibo.it). Under the responsibility of the assignee, the acceptance form is valid to declare there are no incompatibility as in art. 5. Any changes shall be promptly declared.

#### **Art. 7 – Payment**

The payment of the scholarship is subject to the final admission and enrolment in the Second Cycle Degree programme in Tourism Economics and Management, that will be verified by the office. In addition to that, international students must provide a regular residence permit within 31/10/2022. The payment will be confirmed with bank transfer on any Italian bank account or pre-paid card with **Italian IBAN assigned or co-assigned** the assignee.

#### **Art. 8 - Withdrawal**

Withdrawal must be promptly notified via e-mail.

In case of withdrawal or incomplete documents, the scholarship will be assigned to the next in the ranking list (art. 7). The same will occur in case of transfer to a different degree programme in the academic year 2022/2023, and the scholarship need to be reimbursed.

#### **Art. 7 - Information notice concerning data processing**

The personal data provided shall be processed in compliance with the principles and provisions of Italian Legislative Decree no. 196/2003 (Data Protection Act) and the EU GDPR no. 2016/679 and in any case exclusively for the purposes of this call for applications. The Administration reserves the right to verify the truth of the information provided. Without prejudice to the penal sanctions laid down in article 76 of Italian Decree of the President of the Republic no. 445/2000, in the event of fraudulent information being discovered as a result of such verification, the applicant will forfeit the right to the benefit.
