**Abstract of the Call for applications for grants addressed to talented second year students enrolled in Resource Economics and Sustainable Development in the academic year 2022/2023**

**ART. 1 – Subject**

The Head of the Rimini Campus, Alma Mater Studiorum – University of Bologna, offers 2 grants of € 1.200 and € 1.000 (gross of taxes) in order to support talented students regularly enrolled in the international Second Cycle Degree Programme *Resource Economics and Sustainable Development (RESD)* in the academic year 2022/2023 in their second year.

**ART. 2 - Beneficiaries**

The application is open exclusively to candidates first enrolled in the first year in the a.y. 2021/2022, regularly enrolled in the second year in the a.y. 2022/2023 with at least 105 credits registered by 5 July 2023.

**ART. 3 Selection criteria**

The selection will be based exclusively on merit requirements: sum of the grades for each exam, weighted according to their credits.

The grade exam 30 cum laude will value 0.33 points.

Only exams registered by the **5 July 2023** will be considered.

In case of a tie between two or more candidates in the ranking list, priority will be given to the youngest.

**ART. 4 Application procedure**
