



Abstract of the call for application for 2 scholarships addressed to graduates of the Second cycle degree Programme in Business Administration and Management – curriculum Service Management (SEM)

(The Italian language version of the act is prevailing with regard to the exact interpretation of the rules contained within, also in case of potential disputes).

ART. 1 – Subject

The Head of the Rimini Campus, Alma Mater Studiorum – University of Bologna offers 2 scholarships to graduates of the second cycle degree Programme in Business Administration and management – curriculum Service management (SEM) in the academic year 2022/2023 for the amount of € 1.500,00 (gross taxes) for the first ranked and of € 1.000,00 (gross taxes) for the second ranked for the best degree thesis.

ART. 2 – Admission requirements

The application is open exclusively to graduates meeting the following requirements:

- regular enrolment in the first year in a.y. 2021/2022;
- graduation in Business Administration and Management – curriculum Service Management in the academic year 2022/2023 within the regular duration of the course (from July 2023 to March 2024);
- minimum final grade 110/110.

ART. 3 – Evaluation criteria

The grants will be assigned by the evaluation Committee: professors Marco Visentin, Paola Giuri, Giulia Baschieri, as proposed by the decree of the Head of Rimini Campus.

The evaluation will be based exclusively on merit requirements:

- final thesis (quality and authenticity of the thesis, methods of research and analysis, results obtained) max 15 points;
- final grade:
110/110 = 3 points
110/110 cum laude = 5 points
Minimum score: 15/20.

In case of a tie between two or more candidates in the ranking list, the benefit will be granted to the youngest applicant.

ART. 4 – Incompatibility

The scholarship is incompatible with other scholarships or grants with the same aims and in the same period.

ART. 5 Application procedure

The online application shall be submitted within **17th October 2024 – 12 pm (CEST)** on “StudentiOnline”.

In order to apply, the candidate shall:

1. log in www.studenti.unibo.it with the Unibo account username and password;
2. select the button “bandi” (call for applications);
3. select the relevant call for applications “premi per la migliore tesi di laurea (SEM)”

Documents required for the application (or the application will be invalid):

- 1) pdf copy of the final thesis;
- 2) copy of the identity card or passport.

Italian and EU citizens can provide self-certification of professional and academic qualifications, according to articles 46 and 47 of DPR 445/2000.

Non-EU citizens must conform to art. 3.2 and 3.3 of the DPR 445/2000.

Without prejudice to the penal sanctions laid down in article 76 of Italian Decree of the President of the Republic no. 445/2000, in the event of fraudulent information being discovered as a result of such verification, the applicant will forfeit the right to the benefit.

ART. 6 - Acceptance

Selected candidates shall confirm their acceptance of the grant within 10 days from official notification, sending their declaration of acceptance duly signed according to indications received by campusrimini.didatticaseas@unibo.it, or the assignment shall be invalid.

ART. 7 – Information notice concerning data processing

The personal data provided shall be processed in compliance with the principles and provisions of Italian Legislative Decree no. 196/2003 (Data Protection Act) and the European Law GDPR UE n. 2016/679 and in any case exclusively for the purposes of this call for applications.
