Abstract of the CALL FOR APPLICATION FOR TALENTED STUDENTS ENROLLED IN THE SECOND CYCLE DEGREE PROGRAMME IN TOURISM ECONOMICS AND MANAGEMENT

ART. 1 - Subject

The Director of the Campus of Ravenna and Rimini of the Alma Mater Studiorum – University of Bologna, offers **three scholarships** as follows: **n. 1 scholarships for the amount of € 1.500,00** (before tax) and **n. 2 scholarships for the amount of € 1.000,00** (before tax) addressed to students of the second cycle degree programme in Tourism Economics and Management.

ART. 2 - Admission Requirements

The scholarships will be granted in line with the terms and procedures laid down herewith. The application is open exclusively to candidates, who meet the following requirements:

- **first** year students enrolled in the LM TEaM for the academic year 2018/2019,
- to have passed all exams of the first year.

ART. 3 - Selection criteria

The selection will be based exclusively on merit requirements: sum of the grades for each exam, weighted according to cfu. Score = Sum (exam grade x CFU exam). 30L corresponds to 33 points.

In the event of equal score, the benefit will be granted to the youngest applicant.

ART. 4 - Application procedure

Applicants shall submit the attached application form **(Annex 1)** to the following address:

Applications received beyond this term, and applications received by other methods, shall not be considered.

Selected candidates need to confirm acceptance of the scholarship within 10 days from official notification, sending declaration of acceptance together with fiscal declaration duly signed (that will be sent to the winners), or the assignment shall be invalid to the email address: campusrimini.didatticaseas@unibo.it,.
