

# Abstract of the Call for applications for grants addressed to talented second year students enrolled in Resource Economics and Sustainable Development in the academic year 2024/2025

## ART. 1 – Subject

The Head of the Rimini Campus, Alma Mater Studiorum – University of Bologna offers 1 study grant of € 900 (gross of taxes) in order to support talented students regularly enrolled in the international Second Cycle Degree Programme Resource Economics and Sustainable Development (RESD) in the academic year 2024/2025 in their first year.

#### **ART. 2 - Beneficiaries**

The application is open exclusively to candidates who:

- are regularly enrolled in the first year in the a.y. 2024/2025 with 105 credits registered by 4 July 2025;
- have the grade point average (GPA) equal or higher than 27/30 by 4 July 2025.

#### ART. 3 Selection criteria

The selection will be based exclusively on merit requirements considering grade point average (out of 30) changed into grade point average for graduation (out of 110). Each cum laude will value 0.33 points. Only exams registered by the 4 July 2025 will be considered.

In case of a tie between two or more candidates in the ranking list, priority will be given to the youngest.

# ART. 4 Application procedure

To apply:

- 1. Access www.studenti.unibo.it using university credentials;
- 2. Click on "Bandi";
- 3. Select the call for applications of interest

Applicants shall upload:

- 1) the self-certificate of exams passed by 4 July 2025 (transcript of records from studenti online)
- 2) copy of identity card or passport

Application deadline: 4 July 2025, 12:00 (Italian time)

The application will be deemed valid only if the procedure listed above, completed with all required documents. It is not possible to send candidatures via mail service in paper form or via e-mail to the offices. No application sent after the deadline will be accepted.

#### ART. 6 - Acceptance

Selected candidates need to confirm acceptance of the grant by email to <u>campusrimini.didatticaseas@unibo.it</u> within 10 days from official notification, sending declaration of acceptance or the assignment shall be invalid. They will receive instructions on how to fill in the formal acceptance declaration and the fiscal form.
