**Abstract of the Call for applications for grants addressed to talented first year students enrolled in Resource Economics and Sustainable Development in the academic year 2023/2024**

*(This abstract is translated to English just for publicity purposes. For any application and/or dispute resolution and/or for any legal purpose only the Italian version must be taken into consideration)*

**ART. 1 – Subject**

The Head of the Rimini Campus, Alma Mater Studiorum – University of Bologna offers 2 grants of € 900 and € 600 (gross of taxes) respectively in order to support talented students regularly enrolled in the international Second Cycle Degree Programme *Resource Economics and Sustainable Development (RESD)* in the academic year 2023/2024 in their first year.

**ART. 2 - Beneficiaries**

The application is open exclusively to candidates who:

- are or were regularly enrolled in the first year in the a.y. 2023/2024 with 60 credits registered by 31 July 2024;
- have the grade point average (GPA) equal or higher than 27/30 by 31 July 2024.

**ART. 3 Selection criteria**

The selection will be based exclusively on merit requirements considering grade point average (out of 30) changed into grade point average for graduation (out of 110). Each cum laude will value 0.33 points.

Only exams registered by the 31 July 2024 will be considered.

In case of a tie between two or more candidates in the ranking list, priority will be given to the youngest.

**ART. 4 Application procedure**

To apply:

The application will be deemed valid only if the procedure listed above, completed with all required documents. It is not possible to send candidatures via mail service in paper form or via e-mail to the offices.

They will receive instructions on how to fill in the formal acceptance declaration and the fiscal form.
