Abstract of the Call for applications for grants addressed to talented second year students enrolled in Resource Economics and Sustainable Development (academic year 2023/2024)

ART. 1 – Subject

The Head of the Rimini Campus, Alma Mater Studiorum – University of Bologna offers 2 grants of € 900 and € 600 (gross of taxes) respectively in order to support talented students regularly enrolled in the international Second Cycle Degree Programme Resource Economics and Sustainable Development (RESD) in the academic year 2023/2024 in their second year.

ART. 2 - Beneficiaries

The application is open exclusively to candidates who:

- are or have been regularly enrolled in the second year in the a.y. 2023/2024 with at least 60 credits registered by 31 July 2024;
- have the grade point average (GPA) equal or higher than 27/30 by 31 July 2024.

ART. 3 Selection criteria

The selection will be based exclusively on merit requirements considering the grade point average (out of 30) changed into grade point average for graduation (out of 110). Each cum laude will value 0.33 points.

Only exams registered by the 31 July 2024 will be considered.

In case of a tie between two or more candidates in the ranking list, priority will be given to the youngest.

ART. 4 Application procedure

- 1) the self-certificate of exams passed by 31 July 2024 (transcript of records from studenti online)
- 2) copy of identity card or passport.

Application deadline: **1 September 2024, 11 pm (Italian time)**

The application will be deemed valid only if the procedure listed above, completed with all required documents. It is not possible to send candidatures via mail service in paper form or via e-mail to the offices.

Without prejudice to the penal sanctions laid down in article 76 of Italian Decree of the President of the Republic no. 445/2000, in the event of fraudulent information being discovered as a result of such verification, the applicant will forfeit the right to the benefit.

ART. 5 - Assignment

The Evaluation Committee is appointed by the Head of Rimini Campus of University of Bologna: Anna Montini, Rainer Andergassen, Roberto Patuelli (supplemented by any professor of the degree program).

Those who, for any reason, waive the contribution shall give written notification in due time, in order to allow the replacement of candidates.

ART. 6 - Acceptance

Selected candidates need to confirm acceptance of the grant by email to campusrimini.didatticaseas@unibo.it within 10 days from official notification, sending declaration of acceptance or the assignment shall be invalid. They will receive instructions on how to fill in the formal acceptance declaration and the fiscal form.
