Abstract of the Call for applications for grants addressed to talented first year students enrolled, in the academic year 2022/23, in the bachelor degree “Business Economics” – curriculum Financial and Business Management

ART. 1 – Subject

The Head of the Rimini Campus, Alma Mater Studiorum – University of Bologna offers 2 grants of € 1.500 and € 1.200 (gross of taxes) in order to support talented students regularly enrolled in the bachelor degree “Business Economics” – curriculum Financial and Business Management (FINMA) in the academic year 2022/2023 in the first year.

ART. 2 - Beneficiaries

The application is open exclusively to candidates who are (or were) regularly enrolled in the first year in the a.y. 2022/2023 with 61 credits registered by 31 July 2023.

ART. 3 Selection criteria

The selection will be based exclusively on merit requirements: sum of the grades for each exam, weighted according to their credits.

The grade exam 30 cum laude will value 0.33 points.

Only exams registered by the 31 July 2023 will be considered.

In case of a tie between two or more candidates in the ranking list, priority will be given to the youngest.

ART. 4 Application procedure

To apply:

1. Access www.studenti.unibo.it using university credentials;
2. Click on “Bando”;
3. Select the call for applications of interest

Applicants shall upload:

- 1) the self-certificate of exams passed (transcript of records from studenti online)
- 2) copy of identity card or passport

Application deadline: **6 September 2023, 12 pm (noon – Italian time)**

The application will be deemed valid only if the procedure listed above, completed with all required documents. It is not possible to send candidatures via mail service in paper form or via e-mail to the offices. Applications sent after the deadline will not be accepted.

They will receive instructions on how to fill in the formal acceptance declaration and the fiscal form.
