**Art. 1 - Subject**

The Head Manager of the Rimini Campus of the Alma Mater Studiorum – University of Bologna offers 2 study grants for the gross amount of € 2.000 each (before taxes) for outstanding second year EU or non-EU students of the Bachelor's Degree programme in Economics of Tourism, curriculum International Tourism and Leisure Industries, who completed all exams within the call for application deadline with a minimum GPA of 28/30 or higher.

**Art. 2 – Eligible candidates**

The eligible candidates must possess the following requirements:

- Be regularly enrolled on second year, for the academic year 2022/2023, on Degree programme Economics of Tourism – curriculum in International Tourism and Leisure Industries;
- To have completed all exams in study plan within the call for application deadline with a GPA of 28/30 or higher.

**Art. 3 – Selection procedure**

The selection will be based exclusively on merit requirements: sum of the grades for each exam, weighted according to their cfus.

30L corresponds to 31 points.

Only exams taken within the call for application deadline will be considered.

In case of equal points, the youngest candidate will precede.

**Art. 4 - Application procedure: terms and conditions**

Candidates shall apply online on Studenti Online:

2. select “Call for applications”;
3. select the call for applications according to the title of this call.
