ART. 1 – Subject and amount

The Head of the Campus Rimini of the University of Bologna announces the call for applications for three best final thesis, one for the amount of € 2.000,00 (before taxes), the other two for the amount of € 1.500,00 (before taxes) each, for graduates in the Second Cycle Degree programme in Tourism Economics and Management.

ART. 2 – Eligible Candidates

- to have first enrolled in the academic year 2022/2023 in the above mentioned second cycle degree programme;
- to have graduated within the session of march 2025 of the academic year 2023/2024;
- minimum final grade 110/110.

ART. 3 – Evaluation criteria

The grants will be assigned by the following Committee members: Lorenzo Masiero, Judit Zoltan, Laura Vici.

The evaluation will be based on final thesis and final grade, according to following requirements:

- Evaluation of the final thesis, original work, research and analysis method, results (max 15 pt).
- Final grade:
 - \blacksquare 110/110 = 3 pt
 - 110/110L = 5 pt

Minimum score: 15/20

In the event of equal score, the benefit will be granted to the youngest applicant.
