## **N. 3 grants for graduates of the Second Cycle Degree Programme in Tourism Economics and Management**

### **ART. 1 – Subject and amount**

### **ART. 2 – Eligible Candidates**

- to have graduated within the session of march 2024 of the academic year 2022/2023;
- minimum final grade 110/110.

### **ART. 3 – Evaluation criteria**

The grants will be assigned by the following Committee members: Paolo Figini, Anna Cicchetti, Massimo Giovanardi.

The evaluation will be based on final thesis and final grade, according to following requirements:

- Evaluation of the final thesis, original work, research and analysis method, results (max 15 pt).
- Final grade:
  - 110/110 = 3 pt
  - 110/110L = 5 pt

Minimum score: 15/20

In the event of equal score, the benefit will be granted to the youngest applicant.
