ABSTRACT OF THE CALL FOR APPLICATION FOR 6 STUDY GRANTS ADDRESSED TO STUDENTS ENROLLED IN: ECONOMICS OF TOURISM AND CITIES; ECONOMICS OF TOURISM; CURRICULUM INTERNATIONAL TOURISM AND LEISURE INDUSTRIES OF ECONOMICS OF TOURISM; TOURISM ECONOMICS AND MANAGEMENT

Art. 1 Subject

The head of the Rimini Campus of the Alma Mater Studiorum – University of Bologna issues the call for applications for the selection of **6 students**, enrolled in the academic year 2024/2025 on the Degree programme in Economics of Tourism and Cities (code 6054), Tourism Economics and Management (Code 5910), Economics of Tourism (code 8847), and on curriculum International tourism and Leisure Industries (code 8847.A25) of the same Degree programme, who will be attending the Acept Project week about “Sport Tourism” taking place in Finland, at LAB University of Applied Sciences, from the 23rd to the 29th November 2025.

Participating students will conduct an in-depth research on the attractiveness and sustainability during off season in a seasonal tourist destination. The students will work in mixed groups from different nationalities under the guidance of lecturers and professionals. Students may also get an assignment prior to and after the project week.

Selected students will receive a grant of max € 400,00 (before taxes) to cover registration fees, in place activities and partially cover their meals.

The grant will not cover transport costs to and from the location of the Project Week.

The grant will be assigned as follows: 4 grants to students enrolled on the Degree programme in Economics of Tourism and Cities, or Economics of Tourism, or Curriculum Italian Tourism and Leisure Industries of the latter; and 2 grants to students enrolled on the Second Cycle Degree Programme in Tourism Economics and Management.

Art. 2 Eligibility

Applicants shall meet the following requirements:

- 1) Be enrolled for the academic year 2024/2025 to the first cycle degree programme in in Economics of Tourism and Cities, or Economics of Tourism, or Curriculum Italian Tourism and Leisure Industries of the latter, or the Second Cycle Degree Programme in Tourism Economics and Management.
- 2) Finalize enrollment to the academic year 2025/2026 on the same Degree programmes before taking place on the Project Week.
- 3) To have 45 CFU by the beginning of the Project Week,
- 4) not having participated in the previous ACEEPT Project Weeks.

Art. 3 Application procedure

Deadline for application: 23rd May 2025 (12:00pm) exclusively via StudentiOnline:

3. Select the title of the call for applications.

Art. 4 Selection procedure

Based on merit (academic merit and cv) and interview.

Evaluation criteria:

- Merit and CV: max 40 points
- Interview: max 60 points

Applicants shall reach min. 60/100 points to be accepted.

In case of equal score, the younger candidate prevails.

The **Interview** will take place **on 27th May 2025 starting at 14.00 pm** in the Meeting Room, via Angherà, 22 – second floor. In case of motivated impossibility to attend the interview in presence, the candidate can request to arrange a **virtual call, sending an email to campusrimini.didatticaseas@unibo.it within the same deadline of the call for applications.**

The interview will take place in English language to test language skills and to prove the motivation of each candidate. Absent candidates will be excluded from the selection.

This call for applications is valid as convocation.

Art. 5 Results

In case of less candidates for each degree course, the unassigned places will be assigned to the other degree course according to the rankings.

Art. 6 Acceptance

Selected candidates need to confirm acceptance of the grant within 10 days from official notification.

Art. 7 Withdrawal

Those successful candidates who renounce for any reason will have to provide written and timely information in order to allow replacement with a reserve candidate.
