**Abstract of the CALL FOR APPLICATION FOR TALENTED STUDENTS ENROLLED IN THE SECOND CYCLE
DEGREE PROGRAMME IN TOURISM ECONOMICS AND MANAGEMENT**

ART. 1 – Subject

The Director of the Campus of Rimini of the Alma Mater Studiorum – University of Bologna, offers n.1 scholarship for the amount of € 2.000,00 (before taxes) and n. 2 scholarships for the amount of € 1.500,00 (before taxes) each, addressed to students of the second cycle degree programme in Tourism Economics and Management.

ART. 2 - Admission Requirements

The scholarships will be granted in line with the terms and procedures laid down herewith. The application is open exclusively to candidates, who meet the following requirements:

- **first** year students enrolled in the LM TEaM for the academic year 2023/2024 (first enrollment academic year 2023/2024);
- to have passed all exams of the first year with a minimum GPA of 27/30, within the deadline of this call for applications.

ART. 3 – Selection criteria

The selection will be based exclusively on merit requirements: sum of the grades for each exam, weighted according to their cfus.

30L corresponds to 31 points.

In the event of equal score, the benefit will be granted to the youngest applicant.

ART. 4 – Application procedure

Candidates shall apply online on Studenti Online:

1. login www.studenti.unibo.it with institutional username and password;
2. select “Call for applications”;
3. select the call for applications according to the title of this call.

Non-EU citizens must conform to art. 3.2 and 3.3 of the DPR 445/2000.

In case of false declaration and according to art. 76 of DPR 445/2000, the applicant will lose any right to the grant.
