ART. 1 – Subject and amount

The Head of the Campus of Ravenna and Rimini of the University of Bologna announces the call for applications for best final thesis as follows:

- 1 grant for the amount of € 1.500,00 (before tax)
- 2 grants for the amount of € 1.000,00 (before tax)

for graduates in due time in academic year 2019/2020 in the Second Cycle Degree programme in Tourism Economics and Management (within extra session May 2021).

ART. 2 – Eligible Candidates

- first enrolled in the academic year 2018/2019 in the above mentioned second cycle degree programme;
- to graduate within 21 May 2021;
- minimum final grade 110/110.

ART. 3 – Evaluation criteria

The grants will be assigned by the following Committee members (D.D. Rep. n. 3847/2021 Prot. 141420 tit. V cl. 5 del 10/6/2021): Manuela Presutti, Francesco Maria Barbini, Maurizio Mussoni. The evaluation will be based on final thesis and final grade, according to following requirements:

- Evaluation of the final thesis, original work, research and analysis method, results (max 15 pt).
- Final grade:
- 110/110 = 3 pt
- 110/110L = 5 pt

Minimum score: 15/20

In the event of equal score, the benefit will be granted to the youngest applicant.
