#### **ART. 1 – Subject and amount**

The Head of the Campus of Ravenna and Rimini of the University of Bologna announces the call for applications for three best final thesis, each one for the amount of € 3.000,00 (before taxes) for graduates in the Second Cycle Degree programme in Tourism Economics and Management.

#### **ART. 2 – Eligible Candidates**

- to have first enrolled in the academic year 2019/2020 in the above mentioned second cycle degree programme;
- to have graduated within last session of the academic year 2020/2021 (31 May 2022);
- minimum final grade 110/110.

#### **ART. 3 – Evaluation criteria**

The grants will be assigned by the following Committee members (DD Rep. 3388/2022 prot. 126959 tit. V cl. 5 fasc. 78): Paolo Figini, Anna Cicchetti, Massimo Giovanardi.

The evaluation will be based on final thesis and final grade, according to following requirements:

- Evaluation of the final thesis, original work, research and analysis method, results (max 15 pt).
- Final grade:
  - 110/110 = 3 pt
  - 110/110L = 5 pt

Minimum score: 15/20

In the event of equal score, the benefit will be granted to the youngest applicant.

NON-EU citizens living in Italy shall consider commi 2 and 3 art.3 del DPR 445/2000.

In case of false declaration and according to art. 76 of DPR 445/2000, the applicant will lose any right to the grant.

The Administration reserves the right to verify the truth of the information provided.
