Abstract of the call for applications for 2 grants addressed to students enrolled in the first year of Resource Economics and Sustainable Development for developing the official blog STEAMGREEN
(This abstract is translated to English just for publicity purposes. For any application and/or dispute resolution and/or for any legal purpose only the Italian version must be taken into consideration)

ART. 1 – Subject

A call for tutorships (Regolamento di Ateneo sugli assegni di tutorato ex art. 1 lettera b) L. 170/2003) is open for 2 grants for tutorship of 100 hours each and of € 1.385,41 each (before tax) for students enrolled in the first year of the degree programme Resource Economics and Sustainable Development (RESD) with the aim to develop the official blog STEAMGREEN of the international study programme.

The activities requested will be: developing the RESD official blog STEAMGREEN (in English) proposed as project in the application; publishing and sharing ideas and contents in the field of energy, natural resources, sustainability, environment (posting comments, interviews, publishing articles, events, books' reviews, publications, research projects).

The activities will take place from April to October 2021 mainly online, so an Internet connection, a mobile phone and a personal computer are necessary equipment the beneficiaries should possess. No reimbursement for these expenses will be provided. The tutorship does not imply any future employment.

Beneficiaries will be requested to inform monthly the RESD Degree Programme Director on the activities carried out and also to send a report of the activities and results achieved for evaluation after the first 3 months.

ART.2 – Beneficiaries

Beneficiaries are:

- students enrolled in the first year of the degree programme in Resource Economics and Sustainable Development for the academic year 2020/2021;
- students younger than 30 years (referring to the deadline of this call).

ART. 3 - Application procedure

All candidates have to verify the correct receipt of the email. The office disclaims any responsibility in case of misplaced delivery or misunderstanding.

Applications sent by email after the deadline will not be accepted.

Documents required for the application together with **Annex 1** (or the application will be invalid):

- development plan in English for the blog;
- example of an article written in English (one page maximum);
- self-certificate with the transcript of records from studentonline (credits will be considered only if officially registered in the career);
- curriculum vitae;
- copy of the identity card or the passport.

ART. 4 – Evaluation

A list of qualified applicants will be drawn up by the evaluation committee (professors Anna Montini, Roberto patuelli, Rainer Andergassen, substitute Corrado Benassi) assigning the following scores:

- Development plan: up to 30 points
- Example of an article (one page max): up to 30 points
- Curriculum vitae and transcript of records: up to 10 points
- Interview: up to 30 points.

The minimum score to pass the selection is 70 points.

In the event of equal points, the benefits will be granted to the youngest applicant.

The interview will take place online on Teams in English and in Italian and will focus on applicants' motivation and characteristics. Date and time of the interview will be published on www.resd.unibo.it and eventually emailed to applicants at least 3 days in advance.

ART. 5 – Incompatibility

The tutorship is compatible with other ERGO grants and is also compatible with the collaboration 150 hours only if not carried out in the same period.

The tutorship is incompatible with other tutorships ex DM 198/2003, or teaching contracts and tutorship of art. 10) of Regolamento per la disciplina dei Professori a Contratto in the same academic year.

ART. 6 - Renewal

The tutorship can be renewed for the following academic year should beneficiaries be in the same conditions as article 2 above.

ART. 7 – Assignment

The list of qualified applicants will be confirmed by the Head of the Rimini and Ravenna Campuses upon confirmation of no incompatibility and enrollment in the academic year 2020/2021. Beneficiaries will be emailed to @studio.unibo.it the safety guidelines of 3rd June 2020 and will have to complete the online course on safety on <https://elearning-sicurezza.unibo.it/> and pass the final test. A certificate of the test will be available on their studenti.unibo.it profile.

ART. 8 - Acceptance

Selected candidates need to confirm acceptance of the grant within the date indicated in the official notification by the office Ufficio Scienze Economiche, Aziendali e Sociali and also confirm no incompatibilities or the assignment shall be invalid.

ART. 9 – Withdrawal

The beneficiaries who, for any reason, waive the contribution shall give written notification to campusrimini.didatticaseas@unibo.it 10 days in advance. The replacement of candidates will be possible if the withdrawal has taken place after acceptance but before starting the activities and if hours left are more than 100.

ART. 10– Loss of status

The beneficiaries will lose their status if they renounce their studies, if they transfer to another University, if they graduate, if they prove to be unfit for the tutorship. The loss of status will be confirmed by the Head of the Rimini and Ravenna Campuses.

ART. 11 . Payment

The payment will be done within 60 days after confirmation of the end of activities by the Responsible of the Settore Servizi Didattici of the Rimini Campus, upon approval of the Degree Programme Director.
