GENERAL INFORMATION

Aim

The Erasmus+ Programme 2021-2027, established by Regulation (EU) 2021/817 of the European Parliament and of the Council of 20 May 2021, has introduced new mobility formats, supporting Blended Intensive Programmes (BIPs) through Key Action (KA) 131.

BIPs are short, transnational, intensive learning and training programmes that combine in-person mobility (from 5 to 30 days) with a virtual component of variable duration. Every BIP must award a minimum of 3 ECTS credits.

This call for applications aims to identify and select students who are interested in participating in an Erasmus+ BIP in which the University of Bologna is a partner. Students can view available offers and apply for a BIP on the AlmaRM application, by logging in with their personal institutional credentials @studio.unibo.it.

Students may only apply for one BIP offer.

Successful candidates will receive a grant to cover major costs associated with their mobility period abroad and will be able to use the facilities of the hosting university without being charged additional tuition fees (with the exception of any fees normally charged to local students as well).

Duration of mobility

The timing and duration of each mobility period are predetermined. **The physical mobility period abroad is always short-term** (from 5 to 30 days) and always combined with a **compulsory virtual component**.

Each offer posted on AlmaRM specifies the period during which the in-person and virtual components of the BIP take place.

Successful candidates must **attend both the virtual and physical mobility components in full** to retain their status as Erasmus+ students and receive the corresponding grant.

This call for applications is only for BIPs starting between 1st May 2026 and 30th September 2026.

All BIP activities must in any case be completed by 31st July 2027.

Destinations and offers

Every programme provides for only one country of destination among the EU Member States and third countries associated to the Erasmus+ Programme¹.

MOBILITY GRANT

The mobility grant varies according to the number of days of **physical mobility** (in-person activity) and aims to cover major costs to be incurred by each participant.

The **amount** of each grant funded by the EU will be calculated as follows:

| Duration of physical mobility | Amount |
|---|----------------|
| up to the 14 th day of mobility | €79.00 per day |
| between the 15 th and 30 th day of mobility | €56.00 per day |

In addition to the mobility grant, students with fewer opportunities will receive a one-off **extra amount** of €100 for a physical mobility period from 5 to 14 days, or of €150 for a physical mobility period from 15 to 30 days. “Students with fewer opportunities” are financially disadvantaged students (**ISEE 2025** for University subsidies up to €27,948.60) and/or students with special needs arising from physical, mental or health conditions. For further information regarding the extra amount, winners may contact the office after accepting the mobility vacancy.

In all cases covered by this call for applications, the **ISEE 2025** (or documentation for calculating income and assets, for international students) will be acquired automatically, so it is not necessary to upload it when submitting the application.

Travel costs from and to the hosting institution will be covered, subject to submitting proof of travel after the end of mobility. Amounts are stated in the following table; additional details will be made available in the Erasmus+ BIP Guide.

“Distance band” indicates the distance between the administrative headquarters of the University of Bologna and the venue of the activity the participant has to travel, while the amount covers travel costs to and from the place of destination. The distance must be calculated using the distance calculator tool provided by the EU and available at the following link: <https://erasmus-plus.ec.europa.eu/resources-and-tools/distance-calculator>.

“Green travel” means using sustainable means of transport (e.g. train, bus, carpooling, etc.) for travelling to and from the place of destination.

Erasmus+ grants are awarded subject to completion of activities abroad and recognition of completed activities by the competent Body. Students who fail to successfully complete any study activities, who fail to request recognition of completed activities, or who fail to obtain recognition before graduation will be required to return the full amount of funding received.

GENERAL REQUIREMENTS FOR ELIGIBILITY

The call for applications is open to students who meet the following requirements upon applying and before the application deadline:

1. Being enrolled in a Bachelor (first cycle) degree programme, combined Bachelor and Master (single cycle) degree programme, in a Two-year Master (second cycle) degree programme, or in a PhD programme or Specialization School (third cycle) in the academic year when they apply. Enrolment must be completed by the relevant deadline for the degree programme and mobility must take place before graduation. Students must remain enrolled throughout the procedure, i.e. until the activities completed abroad are recognised in their career.

Specialisation school students, residents and PhD students: being properly enrolled in a medical or non-medical specialisation school or a PhD programme administratively run by the University of Bologna.

2. Being enrolled in a study programme included among those covered by the offer for which they apply upon applying and by the application deadline.

Students enrolled in two degree programmes of the University of Bologna at the same time may only apply for either of them. Upon submitting their application, they will be required to choose the degree programme for which they wish to apply. The system will display any BIP offers available for the selected degree programme. The degree programme selected upon submitting the final application will be the one to which the assessment and any subsequent mobility period and recognition of activities refer.

Students enrolled in a Bachelor (first cycle) degree programme who apply for BIP mobility to be carried out during the 1st year of their Two-year Master (second cycle) degree programme must complete enrolment in the Two-year Master degree programme itself before the start of mobility (both virtual and physical activities). These applications, which are submitted in relation to a so-called *carriera futura* (i.e. future career), are conditional upon meeting the relevant requirement. This means that, in order to retain their mobility grant, successful candidates must enrol in a Two-year Master degree programme among those originally included in the offer.

3. Students must be proficient in the language in which the BIP will take place, in accordance with the Common European Framework of Reference for Languages (CEFR) level specified in the offer, proof of which must be provided as instructed in the offer itself.

Under penalty of losing their Erasmus+ student status and grant, students in mobility may not graduate before completing their period of study abroad and obtaining recognition from their Degree Programme Board or other competent Body for learning activities completed at the foreign university.

Non-EU students are personally responsible for checking well in advance any applicable residence permit renewal procedures and whether these are compatible with their selected mobility period abroad. Students will be responsible for any visa procedures and related fees.

INCOMPATIBILITIES

Incompatibilities relate to both grants and the “Erasmus+ student” status. Students at the University of Bologna may obtain one or more Erasmus+ grants for each study cycle, covering a total in-person period up to 12 months (360 days) in each cycle. For single-cycle degree programmes, the maximum number of months allowed is 24 (720 days) over the entire cycle. Erasmus+ BIP mobilities are included in this calculation.

Successful candidates are allowed to receive other types of mobility grants (e.g. Erasmus+ for Study, Erasmus+ for Traineeship, Overseas, scholarship for dissertation abroad, etc.), provided that the in-person mobility periods do not overlap and subject to compliance with the rules of each programme.

Students who apply for this call may not receive any other type of EU grant (including grants for Joint Master Degrees – former Erasmus Mundus Action 1) during the same period in which they receive funding for the Erasmus+ BIP project.

PhD students whose scholarships are funded by the EU (e.g. Italy’s PON, PNRR, and any other EU funds) are not eligible to receive an Erasmus+ BIP grant. However, they may participate with the “Erasmus+ zero grant” status, i.e. without receiving the Erasmus+ BIP grant.

The Erasmus+ BIP grant may be combined with the supplementary PhD scholarship paid for periods abroad, to the extent of the duration of the PhD student’s stay covered by the standard amount of the scholarship as approved each year by the Board of Governors (currently, up to six months). Conversely, the Erasmus+ BIP grant may not be combined:

- with the supplementary PhD scholarship for periods exceeding that duration;
- with any supplementary scholarship funded by the EU (e.g. Italy’s PON, PNRR, and any other EU funds for PhD students). In those cases, the provisions of the PhD project and the applicable funding reporting requirements must be complied with;
- with any other scholarships and grants funded by the University of Bologna.

HOW TO APPLY

Candidates must apply strictly online via the [AlmaRM](#) application, by logging in with their personal institutional credentials @studio.unibo.it and following the guided procedure for the “Bando Erasmus+ BIP 2025/26 (Call 2025)” call for applications.

APPLICATIONS OPEN: 16/02/2026

APPLICATIONS CLOSE: 02/03/2026, by 1 pm

In order to apply, candidates must:

- read the instructions for applicants on the AlmaRM homepage, which explain how to apply online;
- upload the following documents to AlmaRM:
 - self-certification of their degree certificate and list of exams, only if they obtained their first cycle or second cycle degree from another university;
 - document explaining the reasons why they wish to apply for the BIP project (motivation letter);
 - proficiency certificate or self-certification about the CEFR language level when requested as specified in the offer;
 - any other document requested in the offer.

Only one application may be submitted.

All documents must be uploaded to AlmaRM in pdf format (max 2 MB). Failure to do so will result in the application being rejected. Incomplete applications will not be accepted. Final applications submitted and saved may not be amended or cancelled. Candidates may not apply nor submit additional documents in paper format or by e-mail to the offices.

After the application is submitted, an e-mail is automatically sent to the student’s institutional address (@studio.unibo.it) to notify the candidate that the application was uploaded successfully. This e-mail also contains the **single identification number of the application, which will appear in the anonymised ranking list**. Candidates may also find the single identification number of their application by logging in their personal AlmaRM homepage using their institutional credentials.

All official communications about this call for applications will be sent to the institutional e-mail address @studio.unibo.it.

SELECTION PROCEDURE AND CRITERIA

The Evaluation Committees responsible for the selection procedure are indicated in the notes to the BIP offer alongside the applicable selection criteria.

Candidates enrolled in a Bachelor (first cycle), Two-year Master (second cycle) or Combined Bachelor and Master (single cycle) degree programme

For candidates enrolled in a Bachelor (first cycle), Two-year Master (second cycle) or Combined Bachelor and Master (single cycle) degree programme, the following criteria apply for the purpose of forming the ranking lists:



- 1. Opinion of the Evaluation Committee** (up to 40 points) based on the criteria stated in the offer. Any candidates who receive a score of 0 from the Evaluation Committee will be deemed as **not eligible** and will not appear in the ranking list.
- 2. Academic career assessment** (up to 60 points) based on timely student career progression and results, as follows:
 - first cycle and single cycle degree programme students, and second cycle degree programme students enrolled in a year after the first one: the factors which are taken into account in the calculation of the academic career score are the student's average mark normalised to the average mark obtained at the department and in the cycle of the degree programme in which the student is enrolled (results) and the number of University credits earned as at **02/03/2026** with reference to the student's year of enrolment (timely student career progression). Timely student career progression may be assessed in light of any adjustments approved by departments pursuant to the resolution of the Academic Senate dated 21/07/2015;
 - second cycle degree programme students enrolled in the first year: the factors which are taken into account in the calculation of the score are the student's previous academic career, for 6/7, and current academic career, for 1/7. With regard to the student's previous academic career, timely student career progression is assessed based on the time when the candidate sat their final examination², while results are assessed based on the student's final grade normalised to the average final grade obtained at the department and in the cycle of the degree programme in which the student is enrolled. With regard to the student's current academic career, the normalised average is taken into account for results, while the number of University credits earned as at **02/03/2026** is considered for timely student career progression.

Whereas upon application candidates present more than one first cycle qualification, the most recent one is taken into consideration.

For the purpose of forming the ranking lists, the same criteria detailed above also apply to **part-time students** enrolled in a Bachelor (first cycle), Two-year Master (second cycle) or Combined Bachelor and Master (single cycle) degree programme. Their academic career will also be assessed with reference to the student's year of enrolment.

With regard to the **calculation of the timely student career progression score**, please note that:

- if a student **transfers from another university or from another degree programme within the University of Bologna**, consideration is given to the first year of enrolment in the academic system, regardless of the year of the degree programme in which the applicant is enrolled in the a.y. 2025/26;

² For the purpose of assessing the student's career status relevant to this call for applications, the single graduation session approved by the Academic Bodies of the University of Bologna on 27/01/2015 as part of the amendments to the University Teaching Regulations has been divided into the following periods:

- Period 1: 1 April to 31 July (corresponding to the 1st graduation session in the previous system)
- Period 2: 1 August to 23 December (corresponding to the 2nd graduation session in the previous system)
- Period 3: 7 January to 31 March of the following academic year (corresponding to the 3rd graduation session in the previous system)

- if a student **enrols again after withdrawing from studies or losing student status**, the year of new enrolment is considered if the student has been admitted to the first year. If, on the other hand, the student has been admitted to a year after the first one, the calculation is made by virtually dating back the year of enrolment in relation to the year of the degree programme in which the student is enrolled in the a.y. 2025/26.

Candidates enrolled in a PhD programme (third cycle)

For candidates enrolled in a PhD programme, the following criteria apply for the purpose of forming the ranking lists:

1. Opinion of the Evaluation Committee based on the criteria stated in the offer (up to 40 points). Any candidates who receive a score of 0 from the Evaluation Committee will be deemed as **not eligible** and will not appear in the ranking list.
2. PhD programme entrance exam score (up to 30 points).
3. Second cycle degree programme final grade (up to 30 points).

The previous academic career of all students who obtained their previous qualification abroad will be assessed in accordance with the Guidelines for converting final grades approved by the Academic Senate on 11/12/2018.

All students are required to check in advance that their academic career information which appears in the Studenti Online application contains all completed and recorded learning activities, as only activities registered in the student's record-book by **02/03/2026** are taken into account in the calculation of the academic career score.

RANKING LISTS AND AWARD OF MOBILITY GRANTS

The ranking lists will be posted on AlmaRM on **18/03/2026**.

The ranking lists will be anonymised using the **single identification number** that the system assigns to each application and published in order of score out of 100. The ranking lists will only include the single identification number of eligible and successful candidates. This is the only authorised means by which the results of the selection procedure will be published.

Successful candidates must confirm acceptance of the BIP mobility grant **by 24/03/2026 at 1 pm** via AlmaRM.

The updated ranking lists will be posted on AlmaRM on **25/03/2026**. This will be followed by an additional period to confirm acceptance of the BIP mobility grant, which will end on **31/03/2026 at 1 pm**.

Afterwards, the Blended Intensive Programmes and Mobility Process Coordination Office will review the ranking lists of eligible candidates in the event that a successful candidate withdraws or the partner university offers additional places. Eligible candidates who become successful candidates will receive an e-mail on their institutional e-mail account @studio.unibo.it from erasmus.bip@unibo.it confirming

their BIP mobility grant. The ranking lists may only be reviewed until the nomination deadline set by university coordinating the BIP.

PLEASE NOTE! Upon accepting the mobility grant, successful candidates will receive an automatic e-mail confirming acceptance. The acceptance or withdrawal choice via AlmaRM is official and final. Successful candidates who fail to accept by the deadline indicated in the call for applications and/or in official communications by the offices will automatically forfeit their place in the ranking list, which will become available to any candidates next in line.

What to do after acceptance

In order to receive their grant, participants will have to complete certain mandatory administrative fulfilments (mobility agreement, Learning Agreement, etc.).

The recognition of activities carried out abroad is guaranteed and compulsory in accordance with the Learning Agreement.

PhD students must agree their training programme abroad with their PhD Programme Director/Board.
