

Call for application for 1 Visiting Position at the Department of Management – University of Bologna

Art. 1 - Purpose of the call

Alma Mater Studiorum University of Bologna — Department of Management (hereinafter, "DISA") is launching a call for application for a Visiting position for international Researchers **in possession of the status of scholar at risk** invited to carry out activities of dissemination of their knowledge, research methodology, and teaching. They will perform their activities within the Department facilities. The duration of the contract is of 5 months.

Applicants must be citizens or have dual citizenship or be Italians living and working permanently in conflict zones.

Considering the current historical period, priority will be given to at-risk scholars from Ukraine.

Candidates, who in the year of arrival simultaneously hold a position of any kind in an University or in a Research Centre throughout the Italian country, will be excluded.

The Department reserves the right to check the actual candidates belonging to a conflict zone Universities/Research Centres and, if discrepancies or incompatibilities with the criteria set out in this call are found, it will exclude the candidates from selection.

Art. 2 – Amount of the grant

The total amount for this call is € 10.000 (gross amount) to cover a 5 month visiting position as a **Recognized researcher** (R2 - according to the European Framework for Research Career (https://cdn5.euraxess.org/sites/default/files/policy library/towards a european framework for research careers final.pdf).

Art. 3 Activities to carry out

The length of the stay shall be of 5 months. The period of stay shall be continuous so to achieve a fruitful interaction with the Professors and Researchers of the Department.

The activities expected to be carried out are:

- Seminar in the frame of the Ph.D. Programme in Management
- Seminar in the frame of the GIOCA programme
- Research activity on the topic "Heritage at risk". The visiting researcher will collaborate mainly with professor Paolo Ferri.
- Duration: 5 months, from June 2022 (flexible), on the basis of the Italian sanitary conditions and rules due to the pandemic.

The language to implement the activities will be English.

The applications will be evaluated by a Board appointed by the Department. The selection criteria are the following:

- 1. scientific qualification and research experience of the candidate
- 2. relevance of the research interests for the Department

• 3. exposure to risk of the scholar based on the declarations received, also with respect to the positions taken by the Institution of origin.

Art. 4 - Submission

The application, filled in on the basis of the form attached, shall be sent by the deadline of **June 3**rd to the following email addresses: francesca.regoli@unibo.it and p.ferri@unibo.it Please, attach the following documents:

- a copy of passport
- curriculum vitae
- list of publications of the last 5 years
- documentation suitable to demonstrate the risk conditions also with respect to the positions taken by the Institution of origin
- the indication of the chosen period of stay

Assessment of application

The application will be assessed by a Commission appointed by the Department Board. The result of the selection will be published on the website https://bandi.unibo.it/docenti/visiting-fellows and select from the dropdown menu "Dipartimento di Scienze Aziendali".

The selected candidate will receive a letter of invitation with all details, to be signed for acceptance, and a visiting contract.

Formal Requirements for foreign Visiting Professors

The entry and residence in Italy are regulated by the Italian laws and local regulations. It is up to the Visiting Professor to obtain VISA and any other necessary authorization to enter Italy. The selected candidates will be requested either to have a liability coverage for the period to be spent at DISA or to pay the accident insurance policy provided by the University. A health insurance is recommended for non-EU citizens.

All aspects not regulated by the present call are subject to applicable legal, statutory and regulatory provisions.
