**Profile: R4 Leading Researcher (researchers leading their research area or field).**

Experience requested:

- Has an international reputation based on research excellence in their field;
- Demonstrates critical judgment in the identification and execution of research activities;
- Makes a substantial contribution (breakthroughs) to their research field or spanning multiple areas;
- Develops a strategic vision on the future of the research field;
- Recognises the broader implications and applications of their research;
- Publishes and presents influential papers and books, serves on workshop and conference;
- organising committees and delivers invited talks.

Activity to carry out:

- Seminars in the frame of the Ph.D programme - Banking and Finance track focused on "Empirical Corporate Finance".
- *Research activity*: the expert will collaborate mainly with **professors Massimiliano Barbi and Marco Bigelli** in the field of corporate finance, and corporate governance in particular.
- **Duration**: 5 months, starting from the month of February 2022, on the basis of the Italian sanitary conditions and rules due to the pandemic.
- **Grant**: a grant for a total gross amount of **7,500 euro** (including all costs incurred for travel, accommodation and meals).

**Language**

The language to implement the activities will be English.

**Formal Requirements for foreign Visiting Professors**

The selected candidates will be requested either to have a liability coverage for the period to be spent at DISA or to pay the accident insurance policy provided by the University.
