Art. 1 - Object and Purpose

The International Master's Degree Programme in Horticultural Science – IMaHS – LM-69 offers **2 fellowships** for students regularly enrolled in the A.Y. 2023/24. The fellowship amount is **1.350,00 € each**, and it covers the registration fee for the Summer School "*Experimental Auctions: Theory and Applications In Food Marketing And Consumer Preferences Analysis*" that will be held in Bologna (Italy) on July 1-6, 2024.

Art. 2 - Requirements

In order to participate to the call, students have to fulfil the following requirements:

- a) To be regularly enrolled to the Master's degree Programme in International Horticultural Science for the a.y. 2023/2024 and to have complied with the payment of the tuition fees at UNIBO;
- b) To be admitted to the Summer School (following a pre-enrolment application to be submitted using the online form in the Summer School web site).

The possession of the requirements will be automatically verified.

Art. 3 - Awarding Criteria

The ranking will be formulated according to the following criteria:

- Up to 5 points for career performance in the IMaHS program (transcript of records, considering exams registered and marks)
- Up to 5 points for the motivation letter (to be copied in the pre-enrolment form)

Should two or more applicants obtain the same score, the younger will precede.

Art. 4 – Application procedure

Students must first apply for admission in the Summer School through the link available at <https://experimentalauctions.jimdo.com/application-and-enrolment/> and must receive the letter of admission from the Director of the Summer School.

Then, applications for the fellowships must be submitted on “Studenti Online” **by the deadline of 08/05/2024.**

In order to apply, students need to:

- Log in with their institutional credentials on studenti.unibo.it;
- Click on the button “Bandi”;
- Select the call “BANDO PER L’ASSEGNAZIONE DI 2 BORSE DI STUDIO PER LA PARTECIPAZIONE ALLA SUMMER SCHOOL "EXPERIMENTAL AUCTIONS: THEORY AND APPLICATIONS IN FOOD MARKETING AND CONSUMER PREFERENCES ANALYSIS” – JULY 1-6, 2024”.

The applicants will have to upload:

- Self-certification of the exams, which can be retrieved from Studenti Online personal page (“*Iscrizione con esami, date e voti*”);
- Other Diplomas’ certificates (if any);
- Motivational letter.

Art.5 - Ranking Publication and acceptance of the scholarships

The applicants’ ranking will be published within the “Call for applications” documents to be made available on the procedure’s section on the webpage bandi.unibo.it.

Winners will be informed via email (at their address @studio.unibo.it) and will then have **5 days to accept**, otherwise they will give up on their position and the ranking will be slided.

N.B. Only e-mail communications via @studio.unibo.it will be considered as valid.

Art. 6 – Fellowships payment

The fellowship will be paid directly to the Managing Administration Office of the Summer School on behalf of the awardee. In case the event is cancelled or the awardee fails to attend, the fellowship will be also cancelled.

Art. 7 – Incompatibility

Students cannot benefit at the same time from this grant and from any other funding provided by the University of Bologna for the very same aim.

Art. 8 – Personal data
