

CALL FOR APPLICATIONS FOR N. 4 SCHOLARSHIPS FOR DESERVING STUDENTS ENROLLED IN THE "INTERNATIONAL HORTICULTURAL SCIENCE – IMaHS" WHO WILL SPEND THE THIRD SEMESTER AT THE UNIVERSITY OF BOZEN IN THE ACADEMIC YEAR 2021/2022

Art. 1 – Object and Purpose

The International Master's Degree Programme in Horticultural Science – IMaHS – LM-69, jointly offered by Alma Mater Studiorum – University of Bologna (UNIBO) and Free University of Bologna (UNIBZ) offers to students enrolled in the first year (cohort 2020/2021) **four (4) scholarships** for an amount of **1.500** euro each.

Art. 2 – Requirements

In order to participate to the call, students have to fulfil the following requirements:

- a) To have complied with the payment of the tuition fees at UNIBO;
- **b)** To have expressed their commitment to spend the third semester at UNIBZ, starting in autumn 2021.

Art. 3 – Criteria for the formulation of the ranking

The ranking will be formulated on the basis of the total number of credits (CFU – ECTS) acquired during the first semester 2020/2021 (max. 30 credits) and the average mark (max. 30/30). An additional point will be given for each mark equal to 30 cum laude.

On the basis of these criteria, the Commission will assign the score as follows:

- Max. 40 points for the number of credit points achieved out of total credit points available at the end of the first semester;
- Max. 60 points for the weighted average of the marks, adding an additional point for each mark equal to 30 *cum laude*.

Should two or more applicants obtain the same score, those with the higher weighted average of marks will precede. In case of further equal score, the higher number of credits acquired will be considered. In case of possible further equal score, the date and time of the submission of the application will be considered.

Art. 4 – Incompatibility

Students cannot benefit at the same time from this grant and from any other funding provided by the University of Bologna for the very same aim.

Art. 5 – *Application Procedure*

Interested students must apply **on "Studenti Online"** by the deadline 30/03/2021. In order to apply, students need to:

- Log in with their institutional credentials on **studenti.unibo.it**;
- Click on the button "bandi";

The applicants will have to upload a Self-certification of the exams. Students can retrieve this Self-certification from their Studenti Online page ("Iscrizione con esami, date e voti").

Art. 6 – Ranking Publication and acceptance of the scholarships

The results of the call will be available by April 19th, 2021. The applicants' ranking will be published within the "Call for applications" documents to be made available on the procedure's section on Studenti online, on bandi.unibo.it, as well as on IMaHS' webpage.

Winners will be informed via email (at their address @studio.unibo.it) and will then have **10 days to accept**, otherwise they will give up on their position and the ranking will be slided. Winners should enclose to the acceptance email the **personal and financial data forms**, which are made available as attachments to this "Call for applications" on bandi.unibo.it.

N.B. Only e-mail communications via @studio.unibo.it will be considered as valid.

Art. 7 – Grants' payment

The amount of each grant will be transferred to the winners of this call in October, upon the beginning of courses in Bolzano.

Art. 8 – Personal data

Personal data provided shall be processed fairly and for call-related purposes only, in order not to infringe on the applicants' privacy, abiding by the Italian Privacy Act (d. lgs. 196/3) and by the



Regulation (EU) 2016/679 – General Data Protection Regulation. Data processing shall be carried out via computer as well as paper means. Providing the personal data is compulsory in order to take part in the procedure.
