Call for the award of No. 1 (one) Scholarships for Students of NON-EU CITIZENSHIP regularly enrolled in the second or third year of the Bachelor's Degree in *Economics, Politics and Social Sciences* for the academic year 2025/2026

APPLICATION DEADLINE: 14th November 2025, 12.00 pm

This is an adapted translation in English of the original Call for Applications ("Bando NON UE") in Italian and it is made only for publicity purposes. To enforce the call, resolve any dispute and for all legal purposes only the Italian version will be valid, and will prevail in the exact interpretation of the rules contained within.

ART. 1 – OBJECT OF THE SCHOLARSHIPS

A call is established for the assignment of **n. 1 scholarship** in favor of students of NON UE citizenship regularly enrolled in the second year or third year (enrolled on track) of the Economics, Politics and Social Sciences Degree Course for the 2025/2026 academic year.

ART. 2 – AMOUNT AND SETTLEMENT OF THE SCHOLARSHIPS

The winning student will receive a scholarship amounting to **€1,000.00** gross of taxes borne by the beneficiary (equivalent to €1,085.00 gross of taxes borne the recipient's and the department).

ART. 3 – ADMISSION REQUIREMENTS

The following students can apply:

Students who are NON-EU citizens regularly enrolled in the a.y. 2025/2026 in the second or third year of the *Economics, Politics and Social Sciences* degree programme, who meet the following requirements:

- 1) Have achieved a weighted average grade of 26/30 or higher by the application deadline;
- 2) Have an ISEE 2025 below €30,000.00, or equivalent documentation regarding family income and assets (see below for ISEE submission instructions);
- 3) Students enrolled in the second year in the a.y. 2025/2026 must have obtained at least 40 ECTS credits by the application deadline;
- 4) Students enrolled in the third year (enrolled on track) in the a.y. 2025/2026 must have obtained at least 60 ECTS credits by the application deadline.

ART. 4 – SUBMISSION OF ECONOMIC CONDITION DOCUMENTATION – ISEE

Students who have already submitted their ISEE for the calculation of university fees for the a.y. 2025/2026 or for other University or ER.GO benefits are not required to submit it again. The Administration will retrieve the existing data for the purposes of this call.

Students who have not yet submitted the ISEE for other purposes and wish to do so for this call must follow the instructions below

NON-EU STUDENTS - OECD COUNTRIES

To submit the ISEE for this call, it is mandatory to access the “Servizi on line” section on the ER.GO website using SPID credentials, and complete the “Personal Data” and “Economic Data” sections before the deadline. In the “Economic Data” section, applicants must enter the **INPS protocol number** of the *Dichiarazione Sostitutiva Unica (DSU)* used to obtain the ISEE.

For international students with EU nationality or in one of the OECD COUNTRIES who cannot request the ISEE, detailed information on how to present the documentation for calculating the economic condition can be consulted on the University Portal on the page www.unibo.it/DocumentiTasseInternazionali.

If not resident in Italy, they access the ER.GO Online Services platform with their University credentials. **ATTENZIONE: tutta la documentazione relativa alle condizioni economiche sarà oggetto di puntuali verifiche e controlli da parte di ER.GO, in caso di esito negativo i benefici ottenuti saranno revocati.**

STUDENTS FROM PARTICULARLY POOR AND DEVELOPING COUNTRIES - NON-EU AND NON-OECD COUNTRIES

For international students with nationality in one of the countries included in one of the following lists www.unibo.it/PaesiParticolarmentePoveri or www.unibo.it/PaesiNonOcse a fixed and subsidized contribution is made available without the need to present the documentation on the economic conditions, therefore, they can decide to present the economic documentation, as indicated on the University Portal on the page www.unibo.it/DocumentiTasseInternazionali, for the sole purpose of participating in this competition.

The submission of documentation for the sole purposes of this competition must take place by the deadline for the announcement.

ATTENTION: all documentation relating to economic conditions will be subject to timely checks and controls by ER.GO, in the event of a negative outcome the benefits obtained will be revoked.

ART. 5 – RANKING LIST

The scholarship will be assigned to NON-EU citizens students who who submit ISEE or equivalent documentation according to the procedures described in Art. 4. The ranking list will be drawn up starting from the **lowest ISEE (or equivalent value)**. Scholarships will be awarded in order of ranking until all available awards have been assigned. In the event of a tie, priority will be given to the younger candidate. In case of non-acceptance or withdrawal, scholarships will be offered to the next eligible candidates.

The ranking, established by the evaluation committee, will be **formally approved by the Director of the Department of Economics** and published on the portal <https://bandi.unibo.it/> from 12 December 2025.

ART 6 – INCOMPATIBILITY



The scholarships are incompatible with any other scholarships, awards, or contributions granted by the University for the same academic year.

They are also incompatible with:

- Regional scholarships (ER.GO);
- Tuition fee reductions or exemptions ("no tax area" / ISEE-based reductions);
- Scholarships awarded by the Italian Ministry of Foreign Affairs and International Cooperation.

ART. 7 – AWARDING COMMITTEE

Students who have applied by the closing date of the call will be selected by the Evaluation Commission composed of

ART. 8 – APPLICATION SUBMISSION

Interested students must apply exclusively online, under penalty of exclusion, by 14 November 2025 at 12:00 via the Online Students application, <https://studenti.unibo.it>, "Bandi" section.

ART. 10 – AWARDING THE SCHOLARSHIP

The scholarship will be awarded by Decree of the Director of the Department of Economics, based on the merit ranking established by the Selection Committee, and paid in a single installment by the Department of Economics Administration.

ART. 11 – ACCEPTANCE OF THE SCHOLARSHIP

Within ten days of receiving the award notification, the recipient must send an email to: didatticascaravilli.epos@unibo.it, declaring unconditional acceptance of the scholarship and agreement with the terms of this call. Failure to do so will result in forfeiture of the award.

ART. 12 – RENOUNCE OF THE SCHOLARSHIP

In case of withdrawal by a selected candidate or lack of banking information, the scholarship will be offered to
