

Call for 5 merit-based Study Awards of € 2.500 each for deserving students enrolled in the first year of the Master's Degree in Economics (LM cod.8408) in the academic year 2021-2022 who by the 10<sup>th</sup> of October 2022 will have passed at least four out of the five first year LMEC Integrated Courses

APPLICATION DEADLINE: 12th October 2022, 12:00pm

#### 1. OBJECT OF THE SCHOLARSHIP

In order to acknowledge and reward those students of the Master's Degree in Economics (LM cod. 8408) who have passed at least four out of five of the first year Integrated Courses and earned the corresponding credits by the 10<sup>th</sup> of October 2022, LMEC announces a call for 5 study awards of € 2500 each (gross of taxes) for students who have just completed LMEC's first year.

## 2. ADMISSION REQUIREMENTS

In order to apply, the following requirements must be met:

- a) Being enrolled in the first year of LMEC for the first time in the A.Y. 2021-22.
- b) Having passed (and have on your records) by the **10 th October 2022** at least four out of the five LMEC's first year Integrated Courses: Quantitative Methods for Economic Analysis (I.C.), Microeconomics (I.C.), Econometrics (I.C.), Macroeconomics (I.C.) and Finance (I.C.). Moreover, the average grade of these exams must be equal or above 27/30.

# 3. AMOUNT AND SETTLEMENT OF THE SCHOLARSHIPS

The gross amount of each scholarship is € 2500 and it includes all social security charges and taxes to which the recipient is subject by law. The grant does not entitle to any treatment in social security schemes.

### 4. APPLICATIONS

In order to apply, you will have to fill in the application form (Attachment 1) and include: 1) a copy of a valid identification document and 2) your transcript with exams, dates and grades. Applications, addressed to the Head of the Department of Economics of the University of Bologna, will have to be received by the 12<sup>th</sup> October 2022, h 12 p.m. (12:00). Duly filled out application forms shall be sent by email to michela.sandias@unibo.it\_indicating as email subject: "Application for study awards for deserving LMEC students".

Applications received after the above-mentioned deadline and time, or in alternative modes, will not be taken into consideration.

In their application the candidates must indicate, under their own responsibility: family name and first name; date and place of birth; nationality and residence address.



The University of Bologna can check whether the declared information correspond to the truth. In case of false declarations, the winners will lose their right to receive the grant and will be subject to sanctions according to art. 76 DPR 445/2000.

#### 5. EVALUATION

The Awarding Committee will be composed by three members. The scholarships will be awarded to the first five students in a ranking that will be based on the average of the grades obtained in the exams of at least four of the five Integrated Courses of the first LMEC academic year: Quantitative Methods for Economic Analysis (I.C.), Microeconomics (I.C.), Econometrics (I.C.), Macroeconomics (I.C.) and Finance (I.C.). The Committee will consider the average grade, which will have to be equal or higher than 27/30, as well as the number of credits earned in the first year.

In case of equal score, the scholarship will be awarded to the younger candidate.

The ranking established by the Committee will be formally approved by the Head of the Department of Economics and published on the website: <a href="https://bandi.unibo.it/">https://bandi.unibo.it/</a> by the 31st of October 2022.

# 6. ACCEPTANCE, RENOUNCE AND AWARDING OF THE SCHOLARSHIPS

The scholarship winners will be notified by an email sent to their institutional address @studio.unibo.it and will have to confirm the acceptance of the scholarship within 5 days from the notification date, writing an email to michela.sandias@unibo.it. The scholarship winner will have to inform Michela Sandias of any change occurring with respect to what she/he has declared in her/his application. Prizes will be awarded following act of the Head of Department according to the merit-based ranking, and will be disbursed by the Department of Economic Sciences. The scholarship winners can withdraw by writing an email, not beyond the fifth day from the notification date, to the attention of the Head of the Department of Economics to michela.sandias@unibo.it. In this instance, the Committee can decide to award the scholarship to the next eligible candidate, following the established ranking.
