Call for selection

FACILEX: Legal Experts
Justice Programme 2022

Art. 1

Alma Mater Studiorum — University of Bologna — Department of Legal Studies (hereinafter, "DSG" or "Department"), in the framework of the Justice Programme Action Grant 'FACILEX: *Facilitating Mutual Recognition: Analytics and Capacity Building Information Legal eXplainable Tool To Strengthen Cooperation in the Criminal Matter*' (Grant Agreement no. 101089634 - CUP J13C22000650006) funded by the European Commission, has opened a call for n. 1 Legal Expert Fellowships for foreign scholars invited to carry out research activities within the scope of the project.

In particular, the Fellowship shall allow a strong scientific interaction between foreign scholar invited and Professors/Researchers of the Department with regard to the activities detailed in the 'FACILEX' Project (see Annex I).

This interaction shall be developed especially by means of the following activity: drafting joint scientific manuscripts to be published in scientific international journals or international collective volumes.

Art. 2

Legal Expert will be entitled to receive a lump sum compensation for a total amount of 4.500 EUR.

Art. 3

The collaboration will start in September 2024 and end in December 2024.

The application shall include all required documents and shall be uploaded by the candidates by

4 September 2024 at 12:00

on the online platform: <https://personale.unibo.it>.

The application shall be submitted exclusively on-line; any document submitted through other means will not be accepted.

The application shall include:

- personal and professional data of the candidate;
- a scanned copy of the applicant's valid ID or passport;
- applicant's *curriculum vitae et studiorum* and list of publications (last 5 years).



Art. 4

The applications will be evaluated by a Commission appointed by the Department Council.

The Commission will be in charge of the selection of the best application and the definition of the final ranking list.

The selection criteria are the following:

- scientific qualification and research experience of the candidate;
- expertise within the project's domain;
- specific knowledge of the Portuguese legal system.

For each criterion, up to 20 points can be assigned. Only applications scoring at least 40/60 are eligible to be selected.

The Department reserves the right to do not select any candidates if the applications submitted do not satisfy the demanded excellence requirements.

Art. 5

The final result of the selection will be published on the website <https://bandi.unibo.it/docenti/visiting-fellows>.

The invitation will be formalized with a letter from the Head of the Department.

The Legal Expert is required to formally accept the position in one week upon receipt, sending a confirmation message to: dsg.affarigenerali@unibo.it.

Art. 6

The Legal Expert's entry and residence in Italy are regulated by the Italian laws and the local authorities' regulations.

It is up to the Legal Expert to obtain the VISA and any other necessary authorization to enter Italy.

Art. 7

The DSG will activate an accident and third-party liability insurance coverage (RCT).

The RCT will be limited to the activities listed in the agreement concluded with the Legal Expert and taking place within the Department's facilities.

The Fellowship does not provide for any right to benefit from the National Health Service coverage.

Legal Expert is required to arrange for her/his health and social security coverage.

Art. 8

At the end of the research stay, the Legal Expert shall provide an electronic copy of the research report described in Annex I.

In case of non-compliance the Legal Expert will not receive any compensation and will be excluded from the participation to further calls within FACILEX.
