### Call for selection

# JUST-2023-JACC-EJUSTICE – FULL PROOF

### Art. 1

Alma Mater Studiorum — University of Bologna — Department of Legal Studies (hereinafter, "DSG" or "Department"), in the framework of the Programme JUST-2023-JACC-EJUSTICE - FULL PROOF, funded by the European Commission, has opened a call for n. 4 Legal Expert Fellowships for foreign scholars invited to carry out research activities within the scope of the project.

In particular, the Fellowship shall allow a strong scientific interaction between foreign scholars invited and Professors/Researchers of the Department with regard to the activities detailed in the 'JUST-2023-JACC-EJUSTICE - FULL PROOF' Project (see Annex l).

This interaction shall be developed especially by means of the following activity: development of legal research and drafting of legal paper.

## Art. 2

Each Legal Expert will be entitled to:

receive a lump sum compensation for a total amount of 1.200 EUR.

### Art. 3

The collaboration will start in March 2025 and end in November 2025.

The application shall include all required documents and shall be uploaded by the candidates by

### 4 March 2025 at 12:00

on the online platform: <u>https://personale.unibo.it</u>.

The application shall be submitted exclusively on-line; any document submitted through other means will not be accepted.

The application shall include:

- personal and professional data of the candidate; \_
- a scanned copy of the applicant's valid ID or passport;
- applicant's *curriculum vitae et studiorum* and list of publications (last 5 years); -
- the indication of which legal system the candidate intends to focus on, within the geographical boundaries specified in the Annex I.

## Art. 4

The applications will be evaluated by a Commission appointed by the Department Council.

The Commission will be in charge of the selection of the 4 best applications and the definition of the final ranking list.

The selection criteria are the following:

- scientific qualification and research experience of the candidate;
- expertise within the project's domain;
- specific knowledge of one of the legal systems as chosen in the application.

For each criterion, up to 20 points can be assigned. Only applications scoring at least 40/60 are eligible to be selected.

The Department reserves the right to select a lower number of candidates if the applications submitted do not satisfy the demanded excellence requirements.

### Art. 5

The final result of the selection will be published on the website <a href="https://bandi.unibo.it/docenti/visiting-fellows">https://bandi.unibo.it/docenti/visiting-fellows</a>.

The invitation will be formalized with a letter from the Head of the Department.

The Legal Expert is required to formally accept the position in one week upon receipt, sending a confirmation message to: <u>dsg.affarigenerali@unibo.it</u>.

### Art. 6

The Legal Expert's entry and residence in Italy are regulated by the Italian laws and the local authorities' regulations.

It is up to the Legal Expert to obtain the VISA and any other necessary authorization to enter Italy.

## Art. 7

The DSG will activate an accident and third-party liability insurance coverage (RCT). The RCT will be limited to the activities listed in the agreement concluded with the Legal Expert and taking place within the Department's facilities.

The Fellowship does not provide for any right to benefit from the National Health Service coverage.

Legal Experts are required to arrange for their health and social security coverage.

## Art. 8

At the end of the research stay, the Legal Expert shall provide an electronic copy of the research report described in Annex I.

In case of non-compliance the Legal Expert will not receive any compensation and will be excluded from the participation to further calls within 'JUST-2023-JACC-EJUSTICE – FULL PROOF'.
