

Call of the Institute of Advanced Studies for four Visiting Fellows from Ukraine for a period of 12 months

Deadline for the submission of applications: 15 April 2022 (15:00)

Introduction

The aim of the Institute of Advanced Studies (ISA) is to promote and implement direct activities to enhance teaching and scientific interdisciplinarity and the internationalisation of the University of Bologna through the offer of Fellowships to international teachers and researchers. With regard to the tragic outbreak of war in Ukraine, the ISA deems it must act swiftly in this serious emergency to support Ukrainian academics who wish to make use of the hospitality of the Alma Mater Studiorum - University of Bologna, within the scope of the actions envisaged and coordinated by the University of Bologna.

Art. 1 - ISA is offering four (4) Visiting Fellowships with a duration of twelve (12) months, starting indicatively from the second half of the month of April 2022 (or from a subsequent date to be agreed with the ISA), to refugee researchers and professors who are from or in Ukraine or who have permanent residency permits in Ukraine.

Each Visiting Fellow will receive an **all-inclusive stipend in the amount of 25.000 euro (gross)** and will be provided with **accommodation in a single room** (with use of a shared kitchen) in the Irnerio Collegio Superiore Halls of Residence in Piazza Vittorio Puntoni 1 in Bologna.

Art. 2 – Candidates for the Visiting Fellowship must complete the Application Form attached to the Call for Applications and send it **by email** to <u>direttrice.isa@unibo.it</u> copied to <u>segreteria.isa@unibo.it</u> by the indicated deadline.

The application must include:

- 1. personal and professional details of the Visiting Professor candidate;
- 2. scanned copy of his or her passport and, for non-Ukrainian citizens, his or her permit of stay in Ukraine;
- 3. signed declaration confirming that he or she belongs to one of the categories envisaged in the call as indicated in Art. 1;
- 4. brief scientific profile of the Visiting Professor with his or her *Curriculum vitae et studiorum;*
- 5. description of the research project that the Visiting Professor intends to carry out during the Fellowship;
- 6. description of any teaching activities proposed for the Institute of Advanced Studies and the Institute for Higher Studies (ISS);
- indication of the Department, research group or teacher of the University of Bologna with which the Visiting Fellow deems he or she can establish a beneficial scientific and teaching collaboration during his or her year in Bologna (in the absence of already existing contacts with teachers or research groups at the Alma Mater, candidates are advised to consult the University website <u>Campuses and</u> <u>structures — University of Bologna (unibo.it)</u>).



Art. 3 – The applications will be assessed by a Committee nominated by the Rector of the University of Bologna.

Having verified that the applications are consistent with the eligible applicant categories, the selection committee will evaluate the:

- i. *curriculum vitae et studiorum* of the candidate;
- ii. consistency of the candidate's profile and research project with the activities of the Department, the research group or teacher indicated by the candidate for the Visiting Fellowship in his or her application;
- iii. relevance of the research project and teaching activities of the candidate to the objectives of the ISA and ISS.

Art. 4 – The results of the selection procedure will be published on the competitions section of the University website https://bandi.unibo.it/ and the ISA website and successful candidates will be notified by email.

Art. 5 – Within 7 days of receipt of the communication, acceptance of the Fellowship by the Visiting Fellow must be communicated by sending an email to <u>direttrice.isa@unibo.it</u> copied to <u>segreteria.isa@unibo.it</u> by the indicated deadline. If the Fellowship is not accepted or if the acceptance communication does not arrive before the deadline, the Fellowship will be offered to the next candidate on the shortlist.

The start date of the Fellowship will be agreed between the Visiting Fellow and ISA and cannot start later than June 1, 2022.

Art. 6 – During their year in Bologna, the selected Visiting Fellows will be required to actively participate in teaching and scientific initiatives promoted by the ISA and ISS and to collaborate in relation to the activities of the Departments, research groups or teachers indicated in their application.

Art. 7 – The ISA will provide accident and third-party liability insurance cover (RCT) limited to the activities listed in the contract entered into with the Visiting Fellow, which will be conducted in the structures of the University of Bologna. The selected Visiting Fellows will be subject to the applicable provisions in force for the type of user referred to in Art. 1, in addition to any other further provisions.

Art. 8 – The all-inclusive stipend will be paid upon submission of the required documentation duly completed and signed. Payments will be made monthly.

Each semester, every Visiting Fellow will provide a detailed report of the activities carried out.

Art. 9 – For any matter not covered in this call for applications, the provisions contained in the University of Bologna Bylaws and Regulations shall apply along with the applicable provisions of Italian law.
