#### Introduction

## Eligibility

Students enrolled for academic year 2019/20 in the first or second year of the Master Degree in Quantitative Finance at the University of Bologna are entitled to apply to this call, in order to participate to one of the Intensive Courses.

### **Grants**

Participation in the Intensive Programme is free of charge.

Nine grants are available for QF students who will be selected to take part in one of the IPs abroad.

The amount of each grant is equal to 600 € each (gross).

Students will receive the grant before the departure. Once back, they will have to send a certificate of attendance to <a href="mailto:facecon.qfinance@unibo.it">facecon.qfinance@unibo.it</a>

This scholarship is incompatible with other grants for international mobility provided by the University of Bologna during the same period.

#### **Evaluation criteria**

Candidates will be selected based on the following criteria:

- academic merit (up to 50 points);
- -motivation (up to 25 points);
- English language (up 25 points).

All candidates will be acknowledged with a B2 level (no certificates are required). Certificates stating a higher level will be taken into account and will grant a higher score.

In case of equal scores, the grant will be provided to the younger candidate.

- A motivation letter (max length is 1 page) explaining briefly the personal motivation for taking part in this programme;
- Any language proficiency certifications higher than B2
